



Fig.2 Typical Output Characteristics(II)






•Electrical characteristic curves <MOSFET>






• Electrical characteristic curves < MOSFET>



Drain Current : I_D [A]




•Electrical characteristic curves <MOSFET>






Notice

Further rise of inside temperature would cause a thermal runaway. This built-in SBD has low V_F characteristics and therefore, higher leak current.
