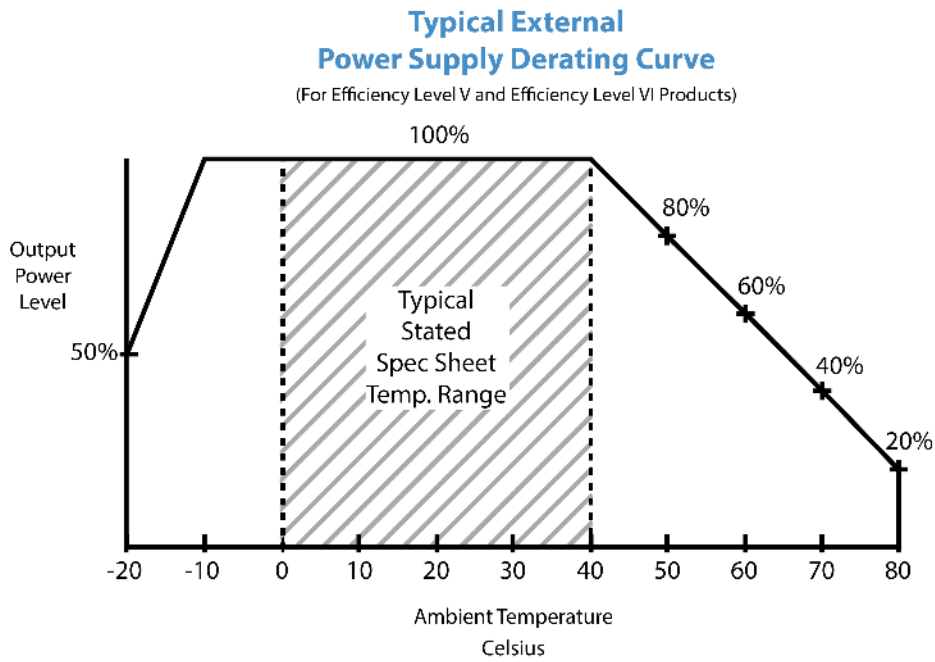

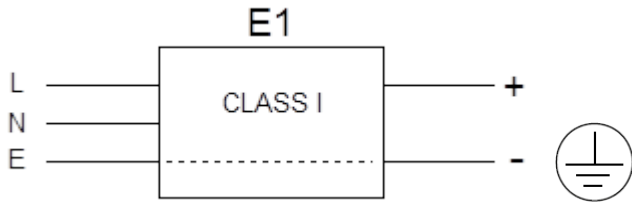
DERATING CURVE

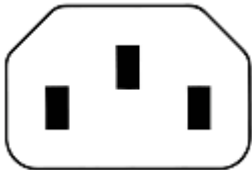
