
## **RELATIVE INTENSITY vs. WAVELENGTH**



## **SPATIAL DISTRIBUTION**











## **REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS**




- 1. Don't cause stress to the LEDs while it is exposed to high temperature.

  3. Reflow soldering is recommended. Other soldering methods are not recommended as they might cause damage to the product.


### TAPE SPECIFICATIONS (units:mm)
