




Fig.1 Input Voltage vs. Output Current

Fig.2 Output Current vs. Input Voltage (OFF Characteristics)




Fig.3 Output Current vs. Output Voltage

OUTPUT CURRENT : I₀ [mA]





Fig.4 DC Current Gain vs. Output Current




Fig.5 Output Voltage vs. Output Current

Fig.1 Input Voltage vs. Output Current




Fig.2 Output Current vs. Input Voltage (OFF Characteristics)




Fig.3 Output Current vs. Output Voltage







Fig.4 DC Current Gain vs. Output Current




