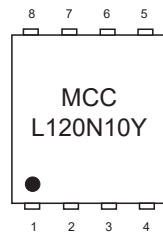
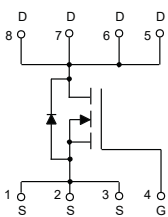

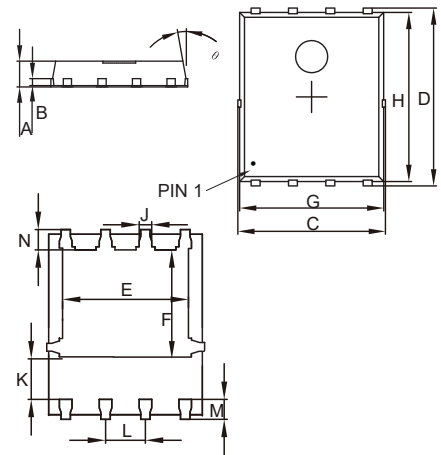

Fig. 1 - Typical Output Characteristics

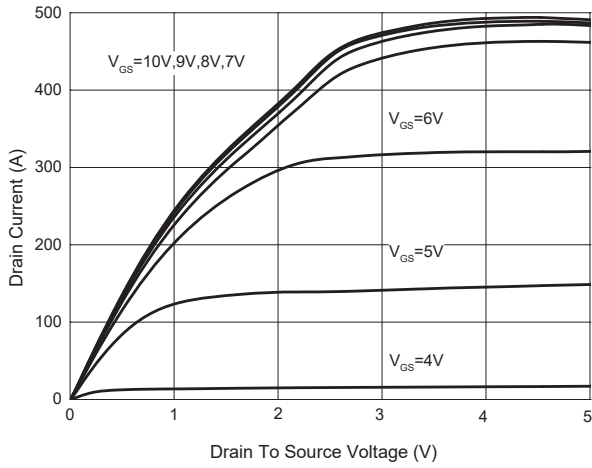


Fig. 2 - Transfer Characteristics

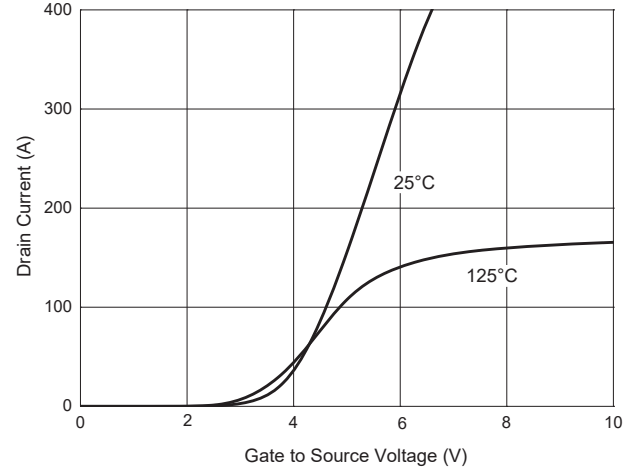


Fig. 3 - Capacitance Characteristics

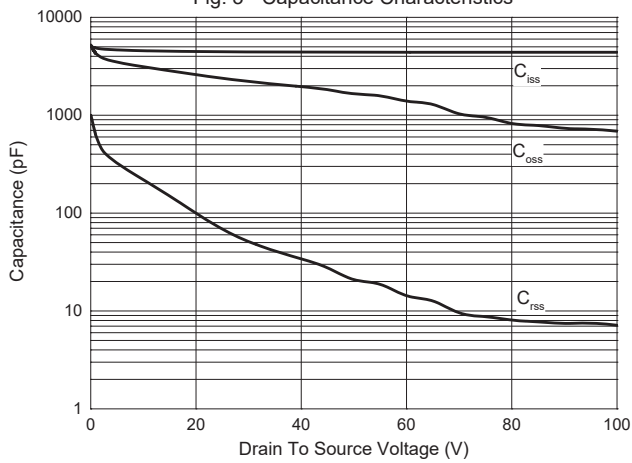


Fig. 4 - Gate Charge

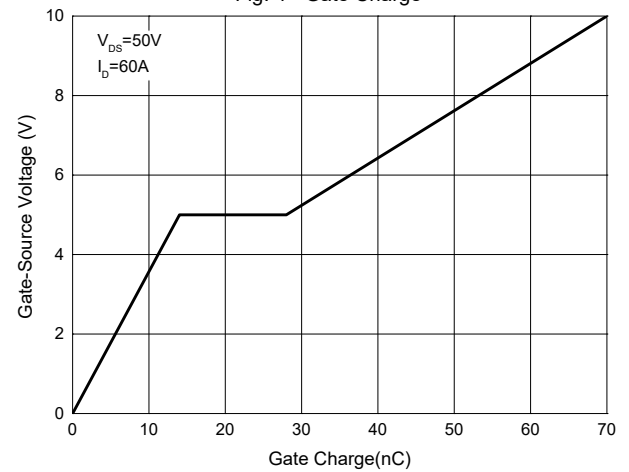


Fig. 5 - $R_{DS(ON)} - V_{GS}$

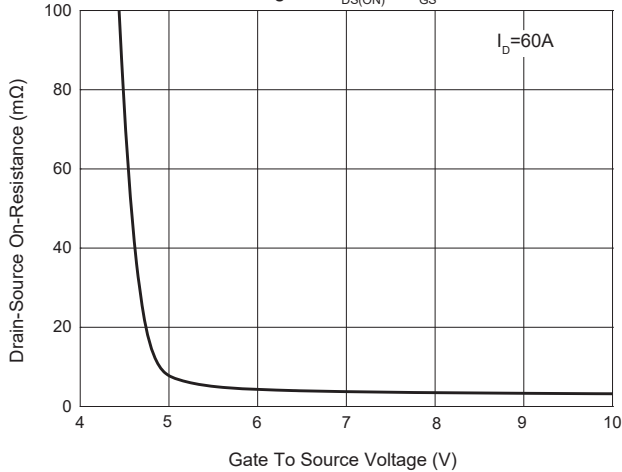
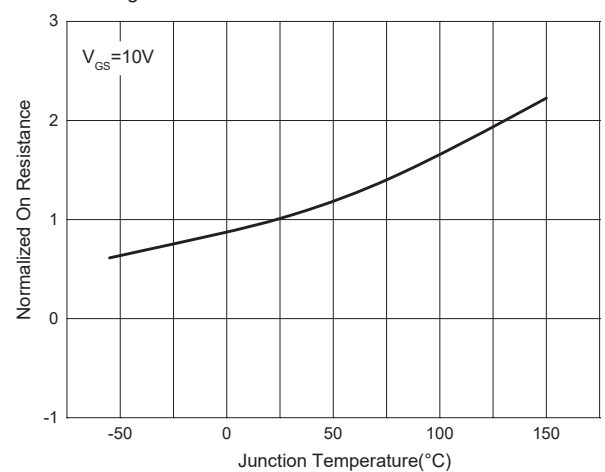
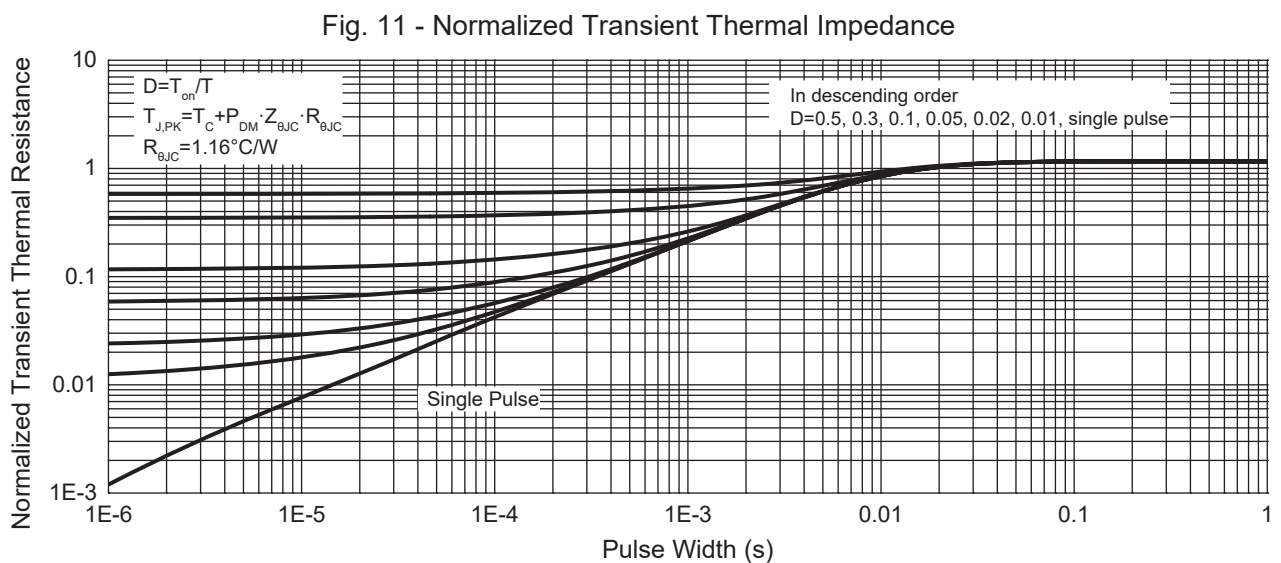
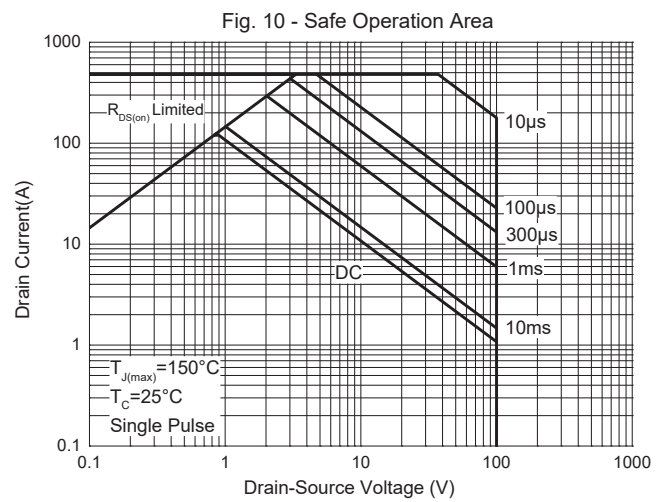
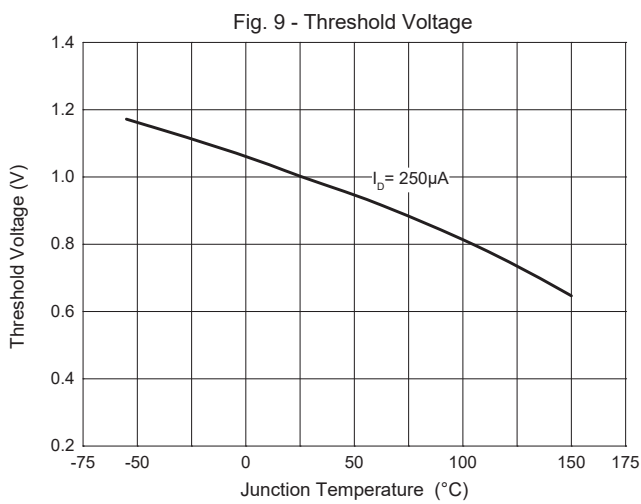
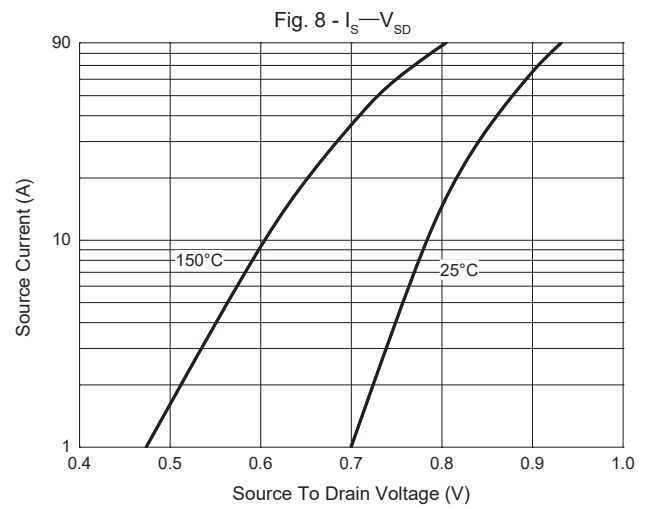
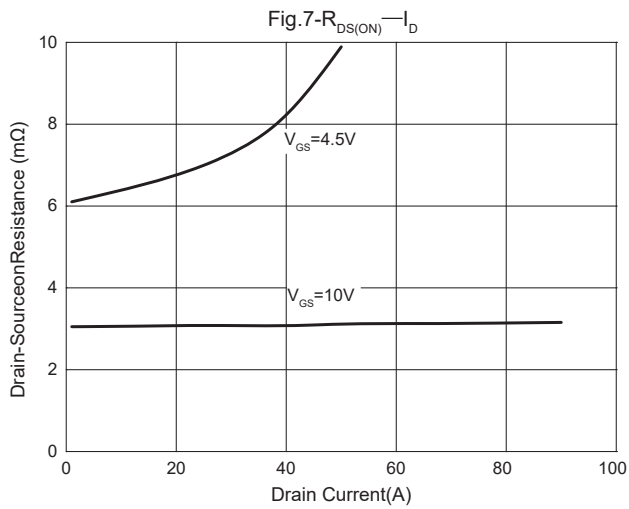


Fig. 6 - Normalized On Resistance Characteristics
