



3 Phase bridge NPT IGBT Power Module



It is recommended to connect a decoupling capacitor between pins 31 & 2 to reduce switching overvoltages, if DC Power is connected between pins 15, 16 & 12. Pins 15 & 16 must be shorted together.





SP3 Package outline (dimensions in mm)







Typical Performance Curve












Turn-On Delay Time vs Collector Current







