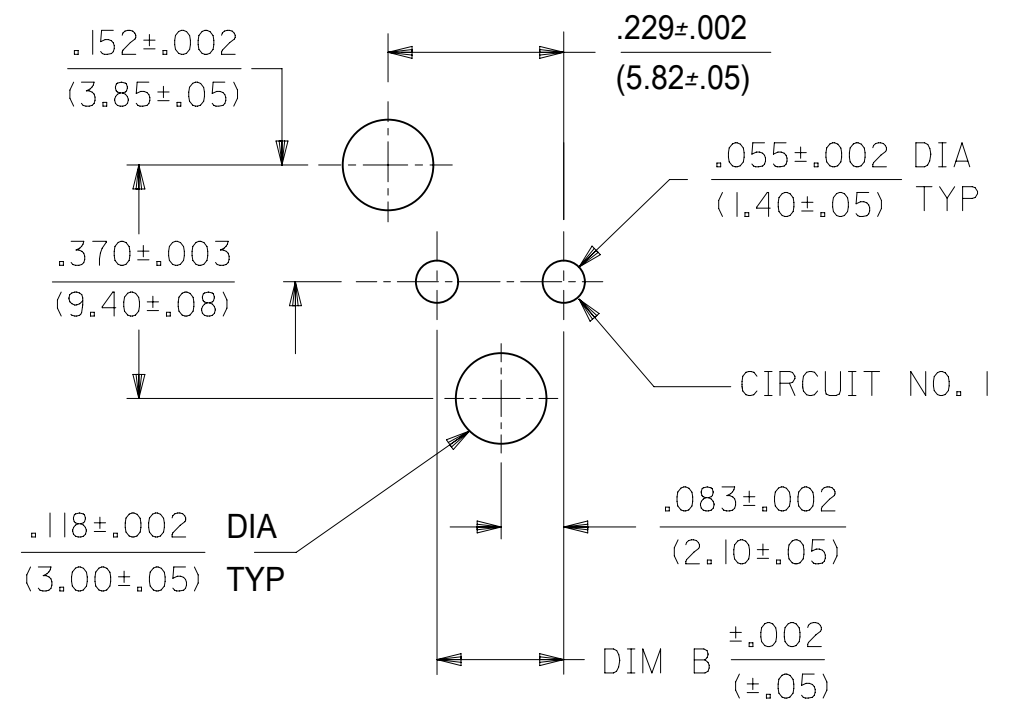
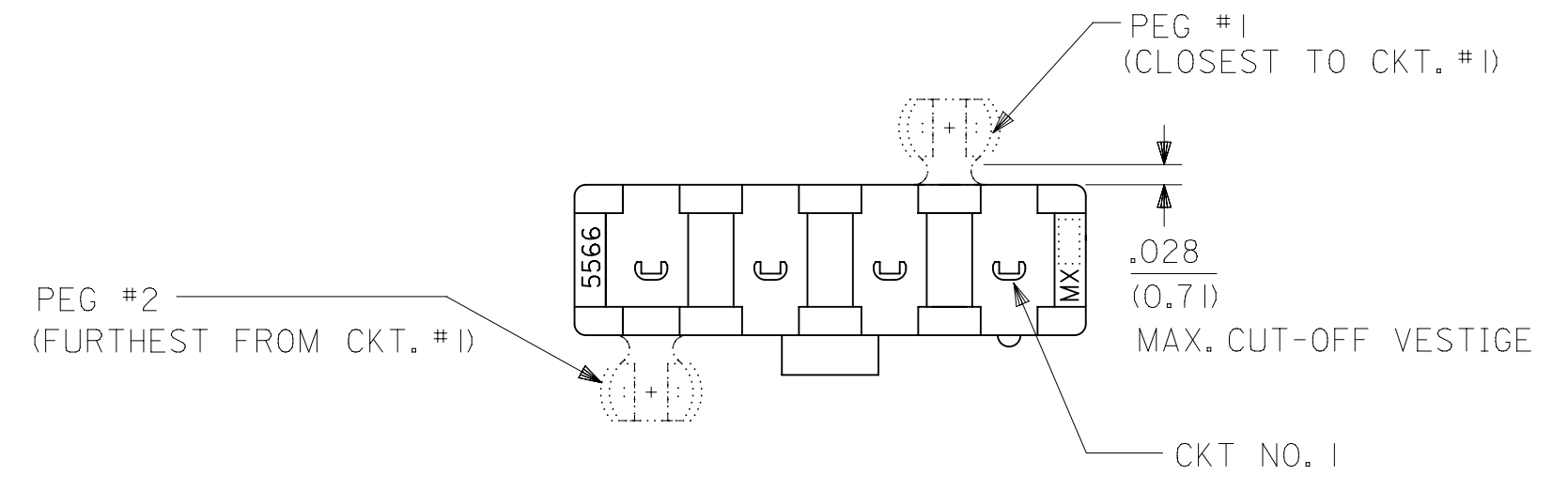
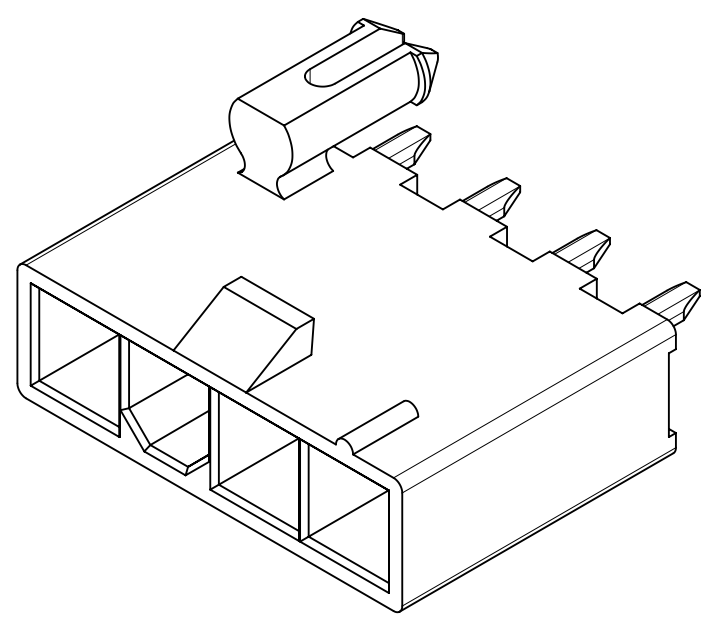
RECOMMENDED HOLE LAYOUT FOR .070/(1.78) MAX. THICK P.C. BOARD

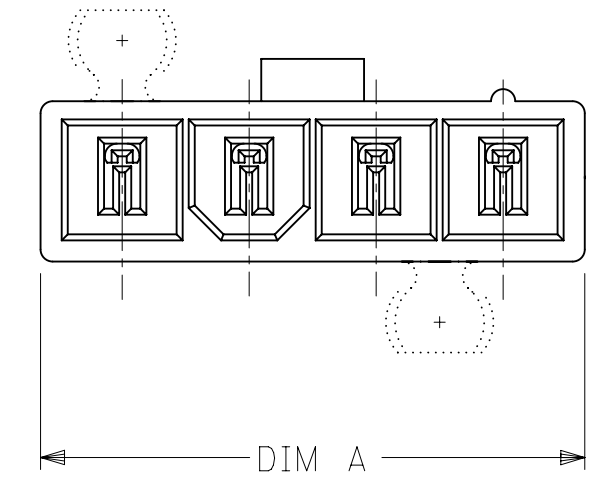
