### Typical Insertion Loss:



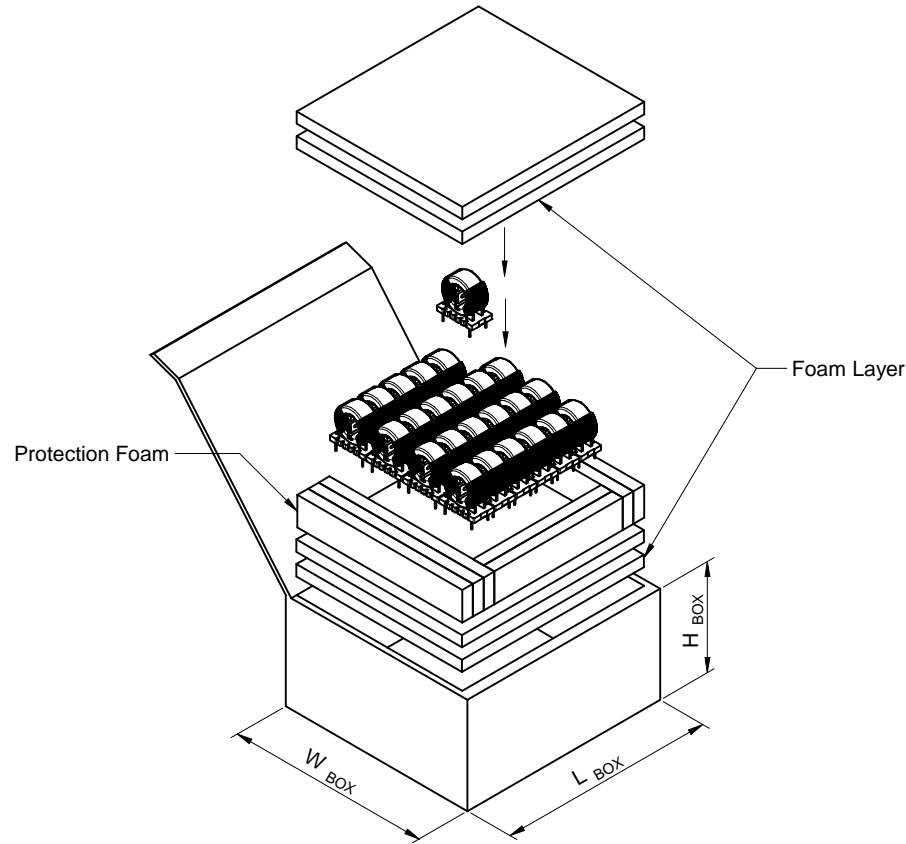

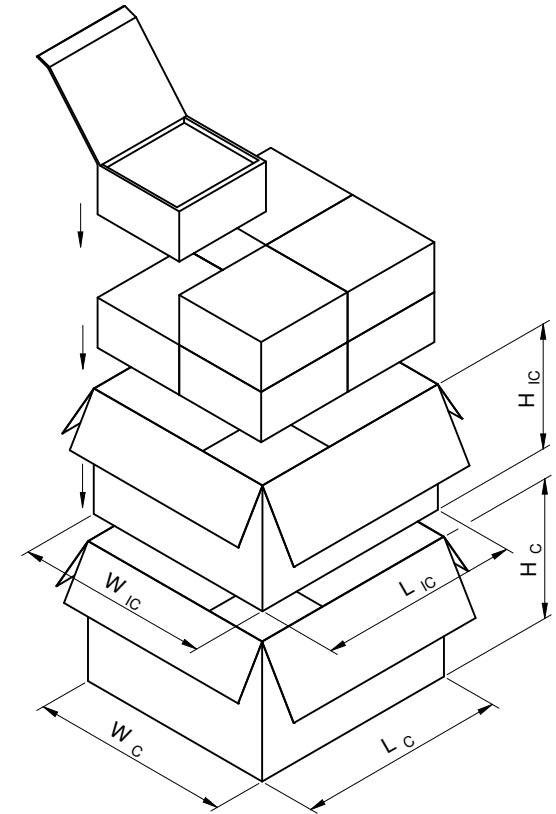

#### Soldering



## Packaging:


