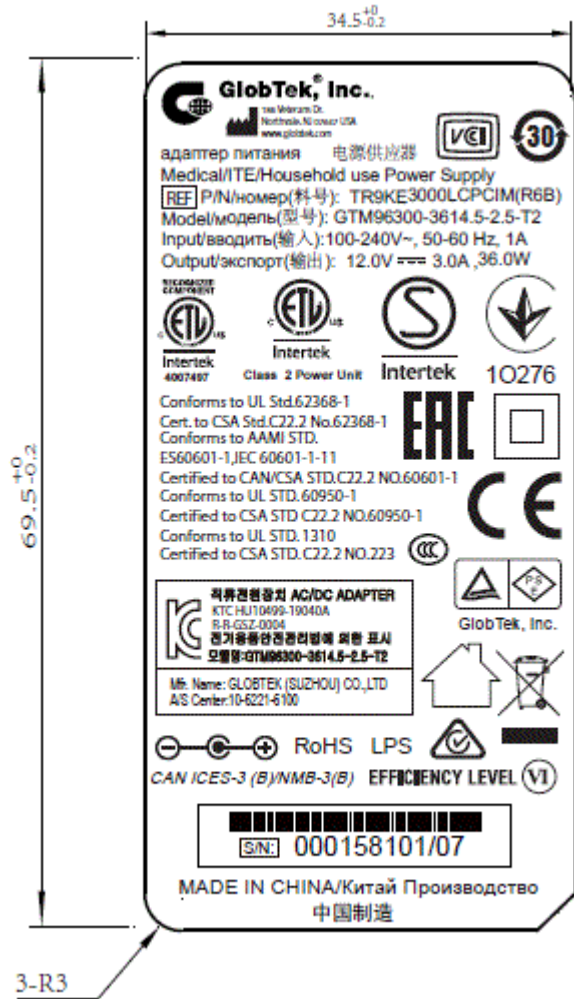

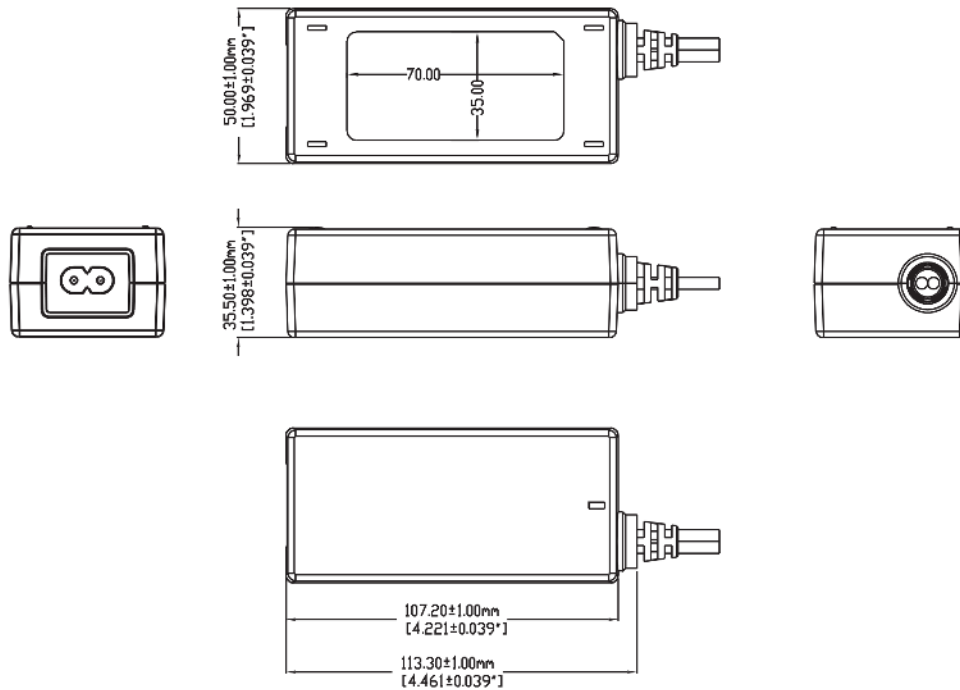

Alternative housing with waterproof barrier. Product PN# ends with suffix "RG"



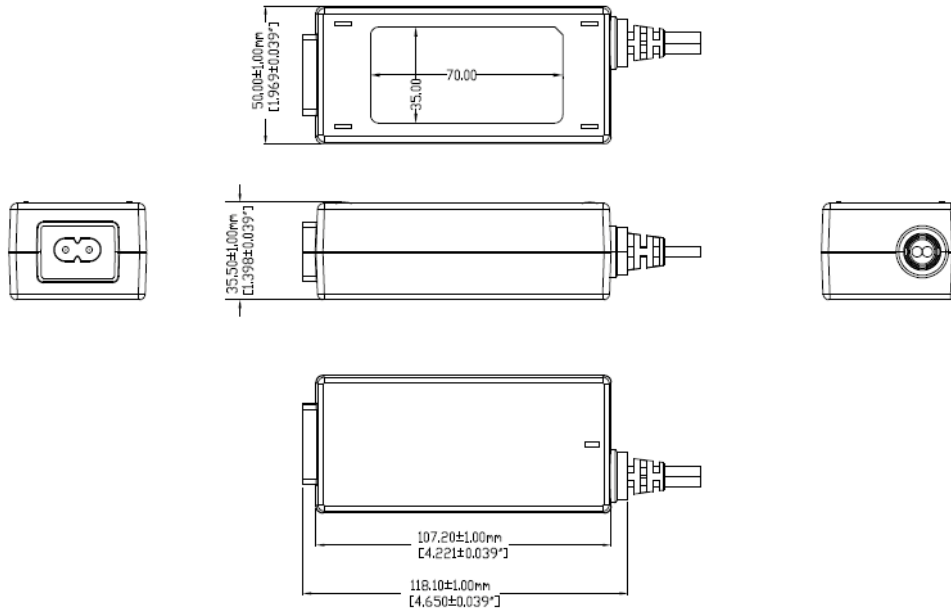
