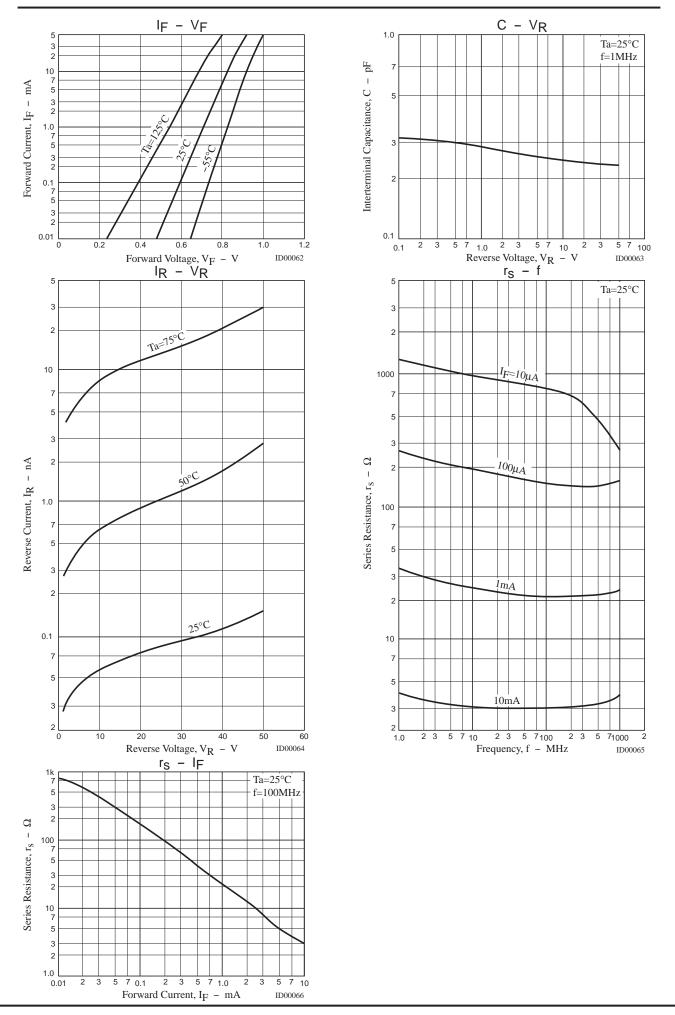

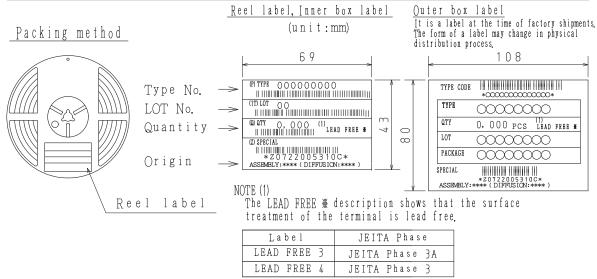

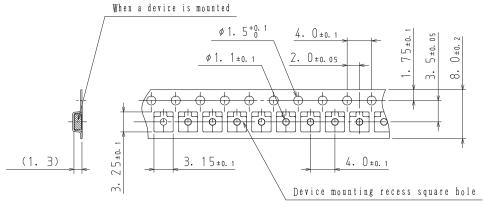

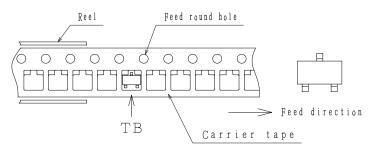


7. Taping configuration

2-2. Device placement direction



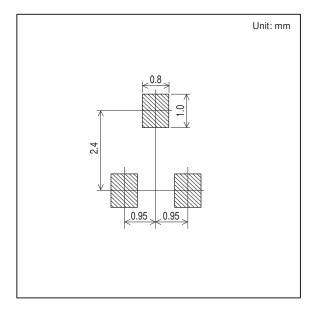
