




Product Specific:

Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the components. Washing agents may have a negative effect on the long-term functionality of the product.

Potting and Coating:

• If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. We recommend a manual inspection after potting or coating to avoid these effects.

Storage Conditions:

- A storage of Würth Elektronik products for longer than 12 months is not recommended. Within other effects, the terminals may suffer degradation, resulting in bad processability. Therefore, all products shall be used within the period of 12 months based on the day of shipment.
- Do not expose the components to direct sunlight.

Packaging:
