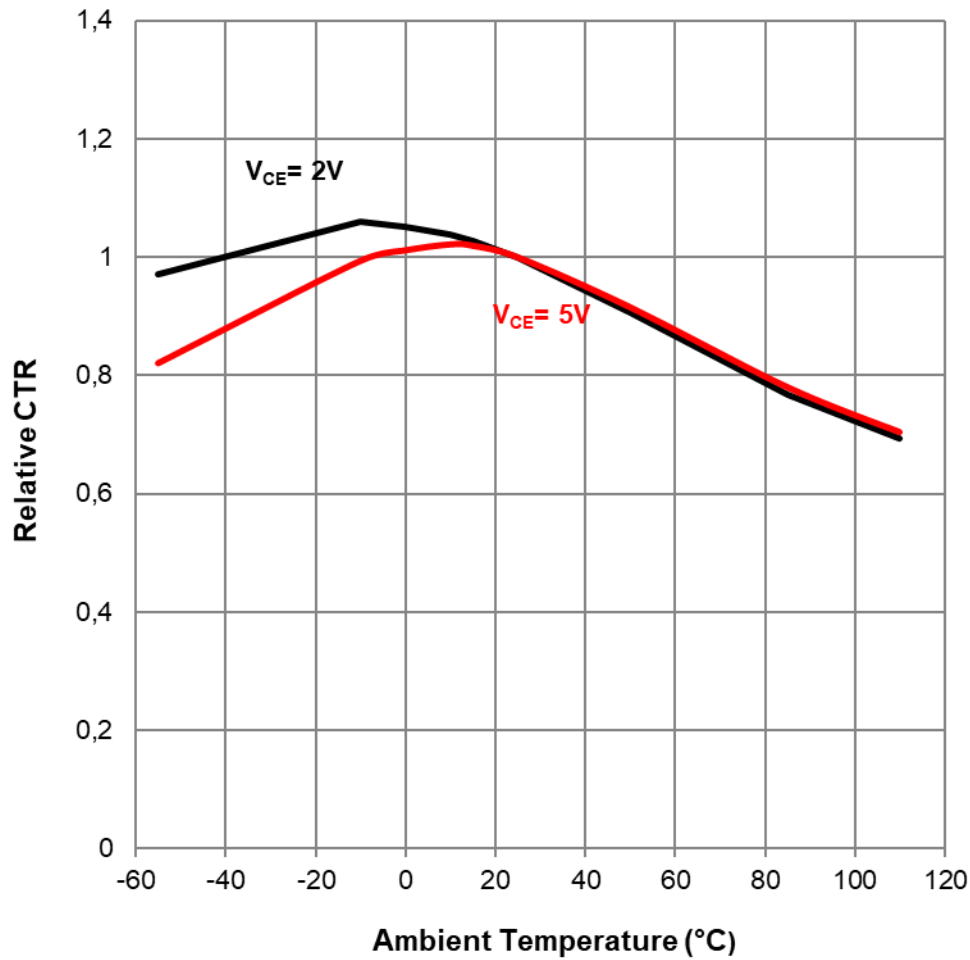


### Collector Dark Current vs. Ambient Temperature:



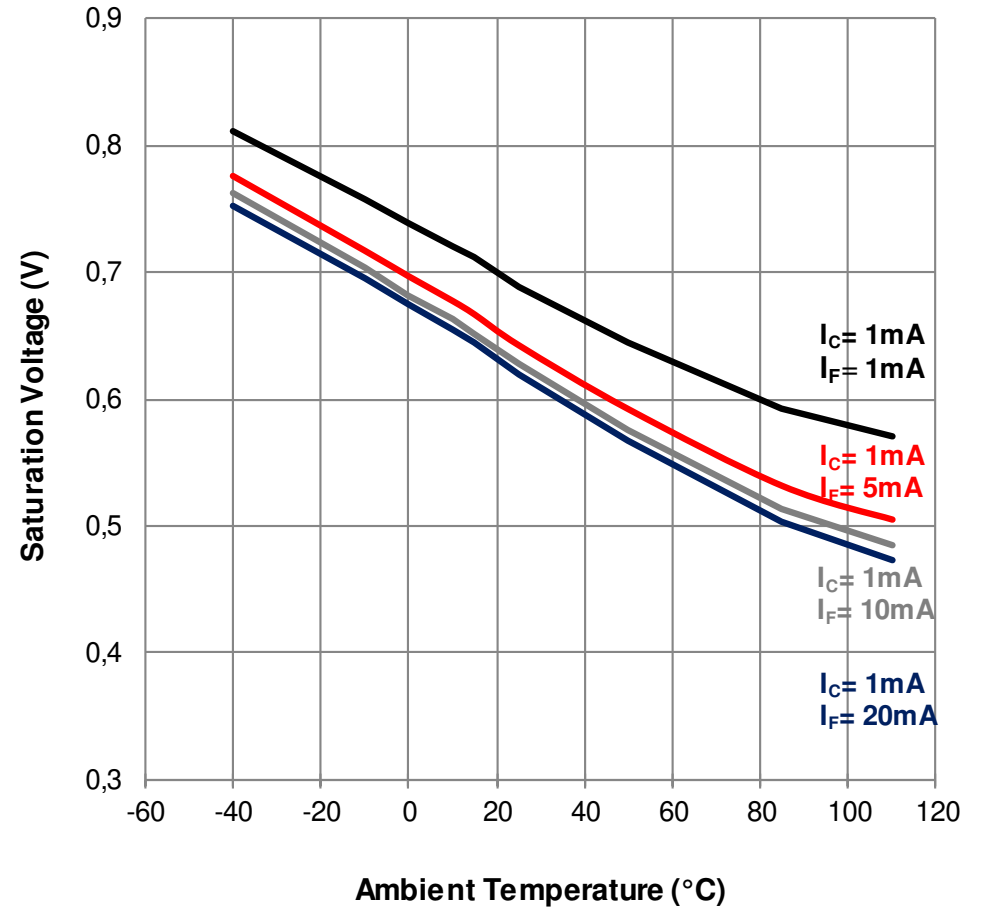

### Relative CTR vs. Ambient Temperature:



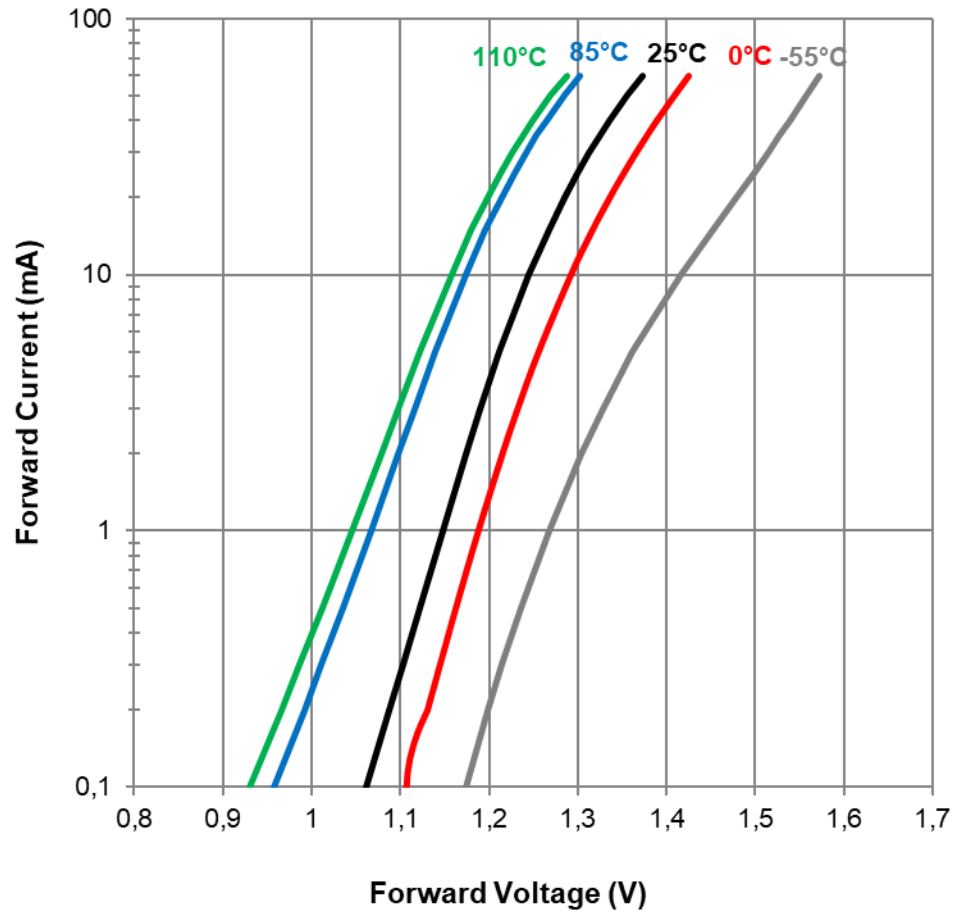

### Collector-Emitter Saturation Voltage vs. Ambient Temperature:

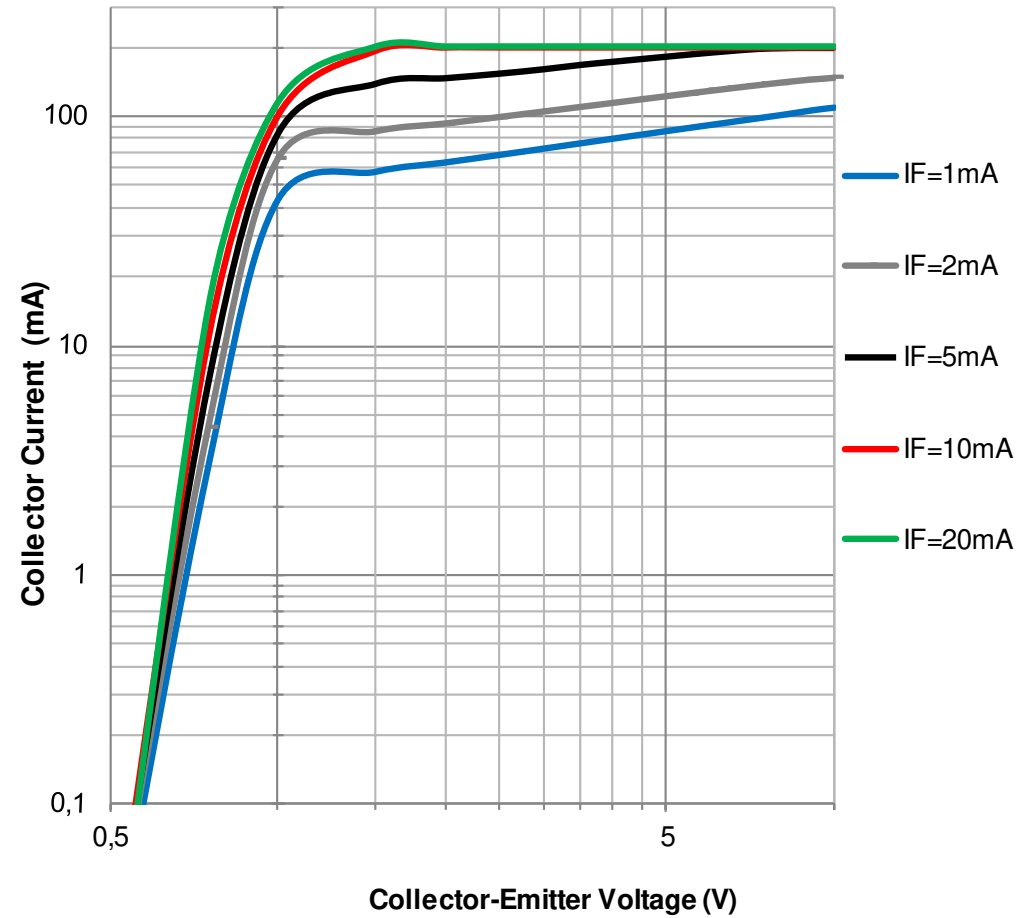

### Forward Current vs. Forward Voltage:



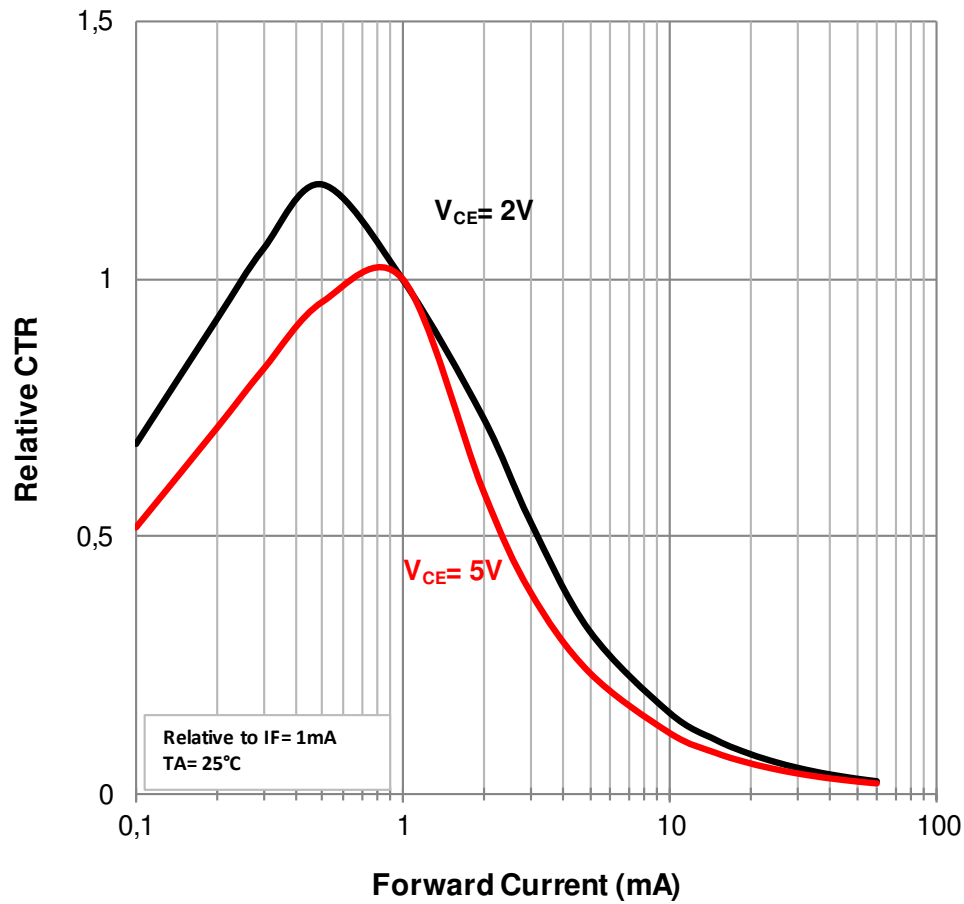

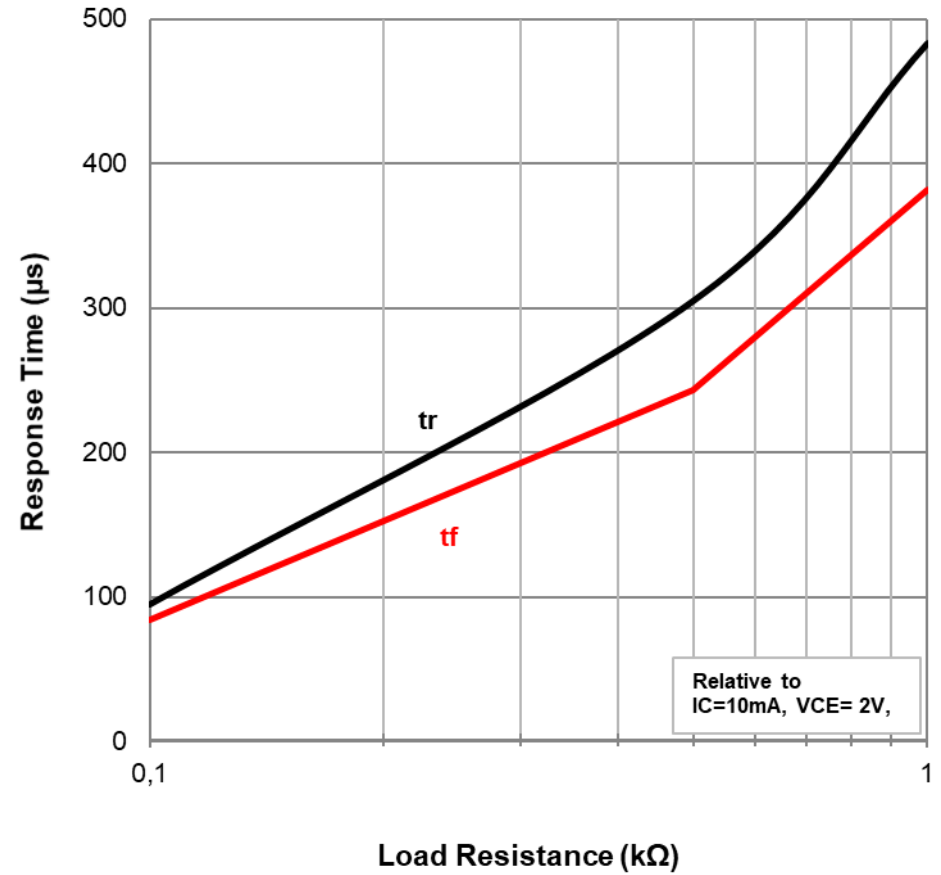

### Relative CTR vs. Forward Current:



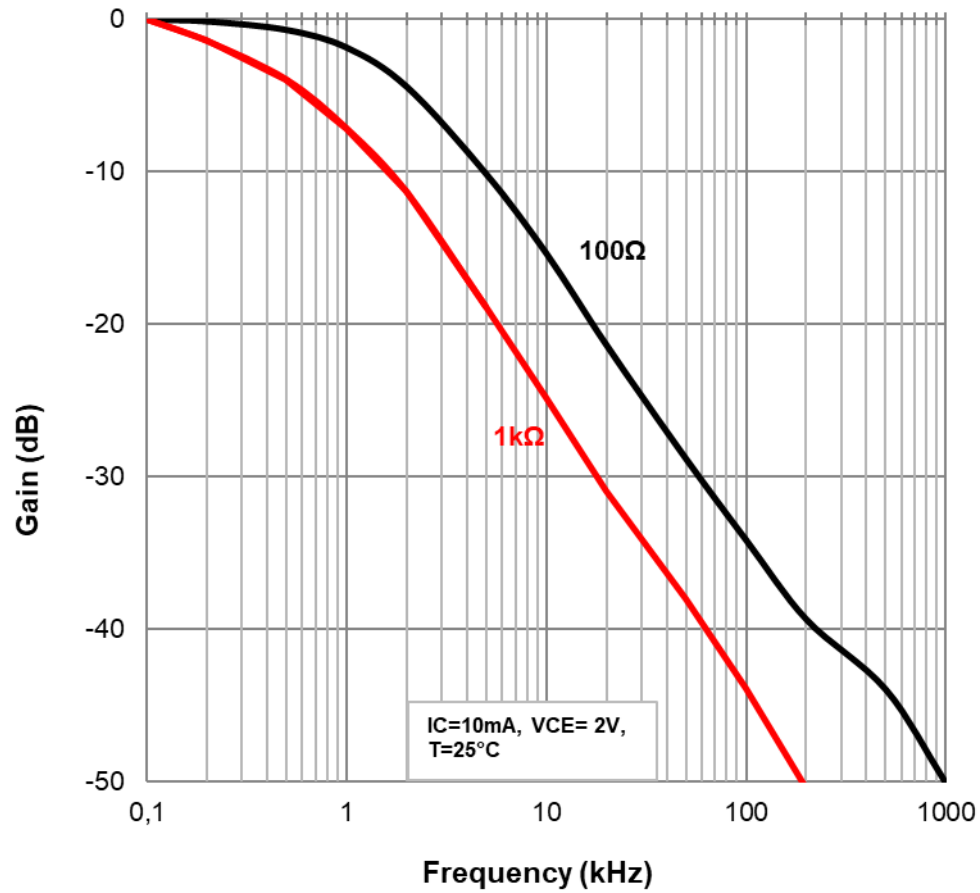

#### Soldering:



In case of further queries regarding the PCN, the field sales engineer or the internal sales person in charge should be contacted. The basic responsibility of the customer as per Section 1 and 2 remains unaffected.

## 6. Product Life Cycle



