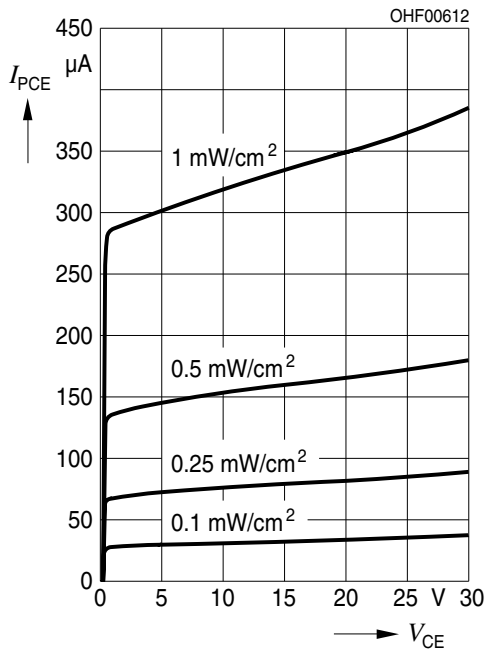

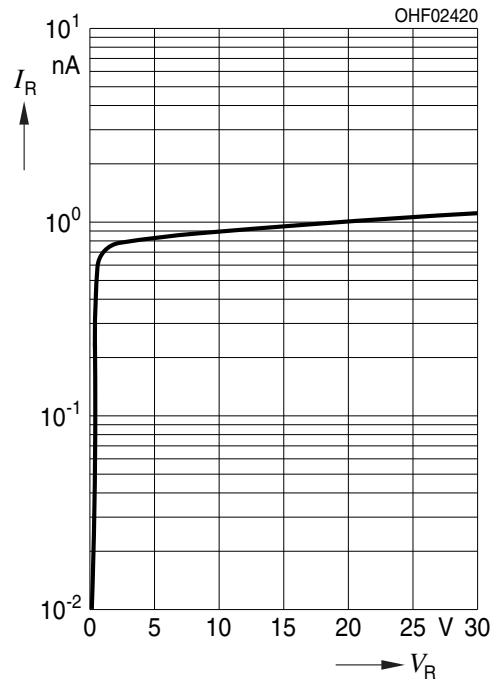

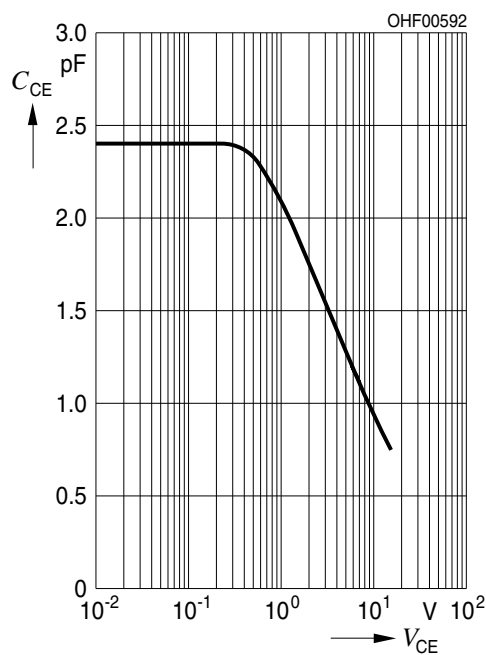

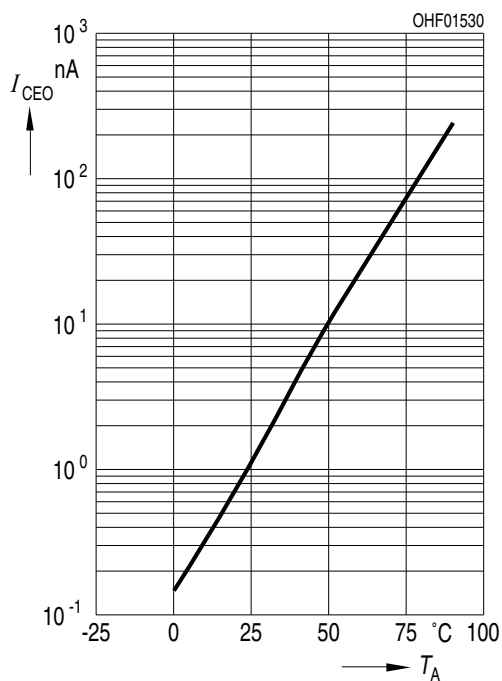

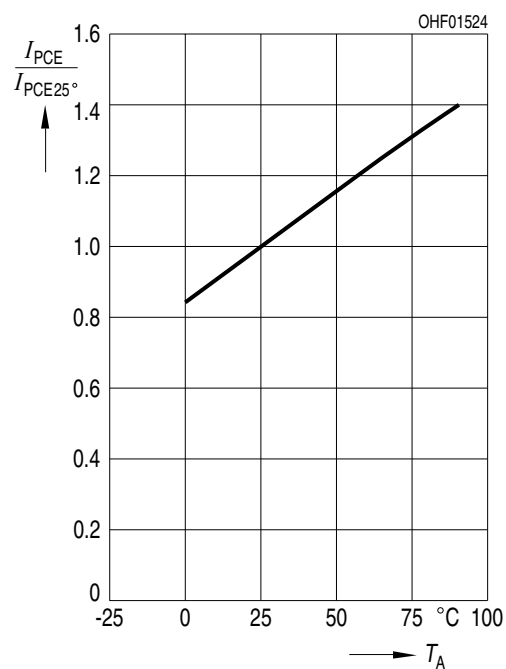

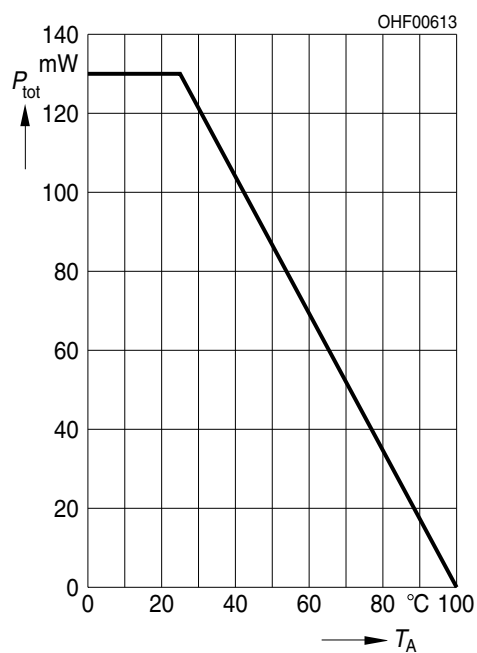

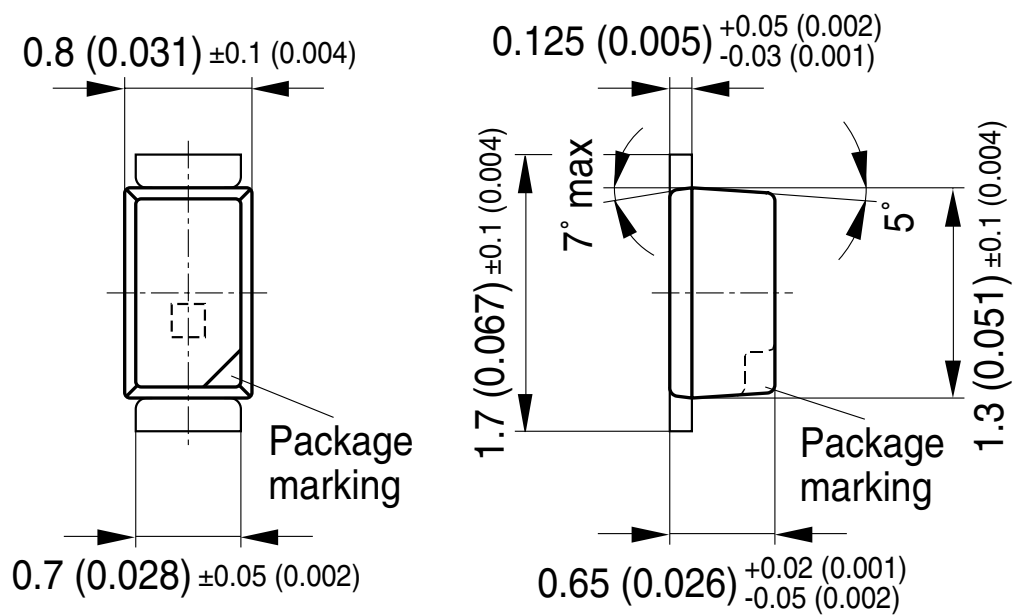


Power Consumption

Dimensional Drawing ⁴⁾

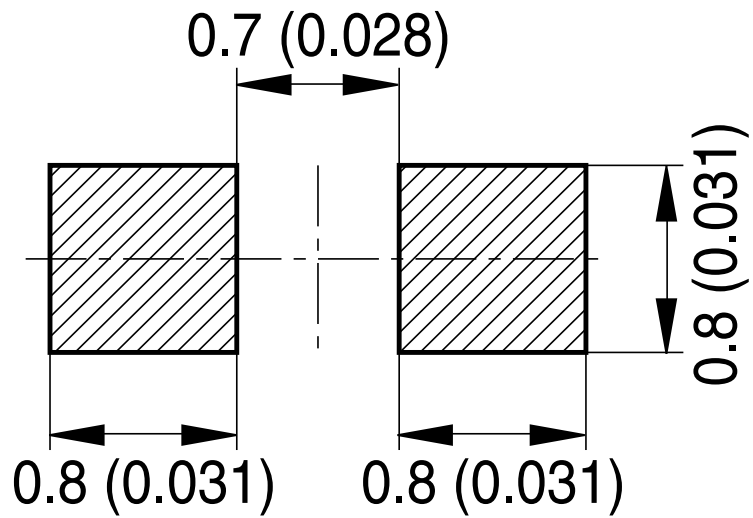

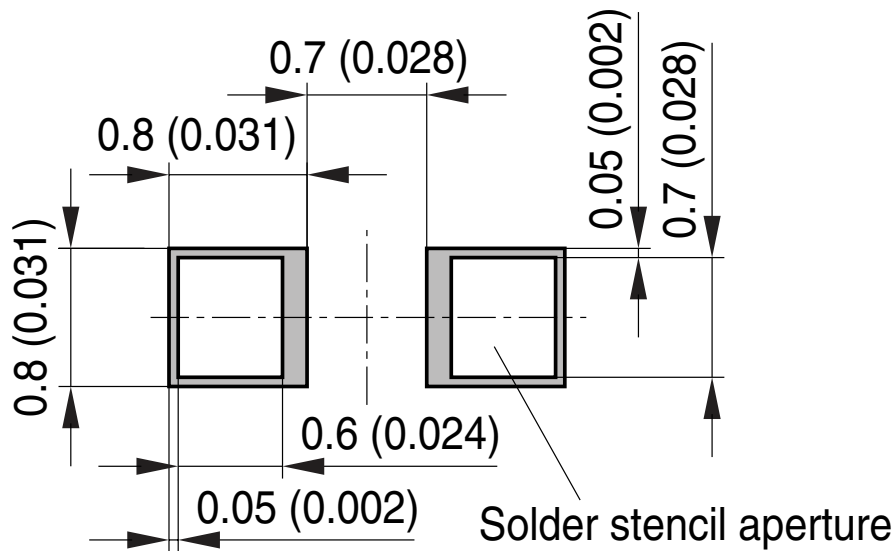

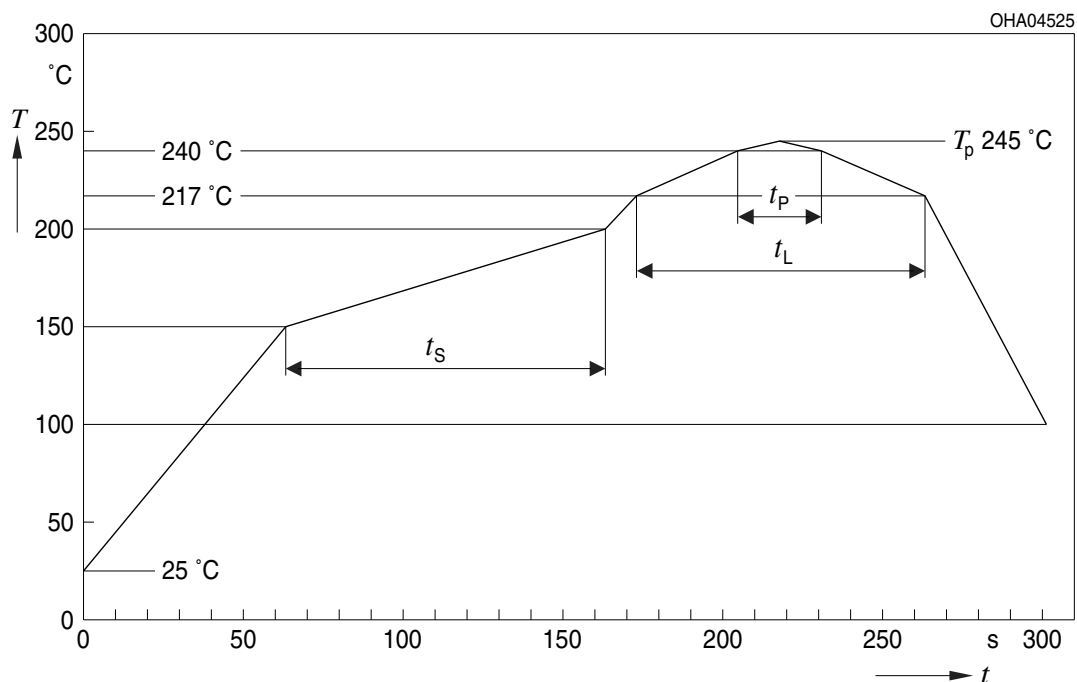

Reflow Soldering Profile

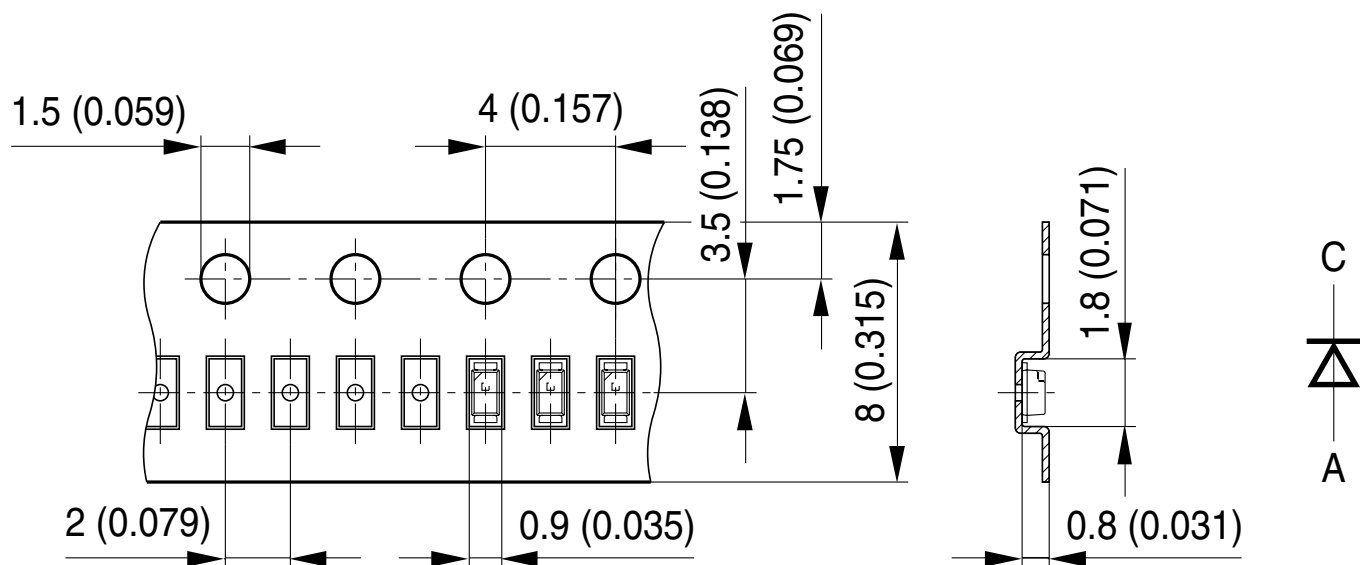

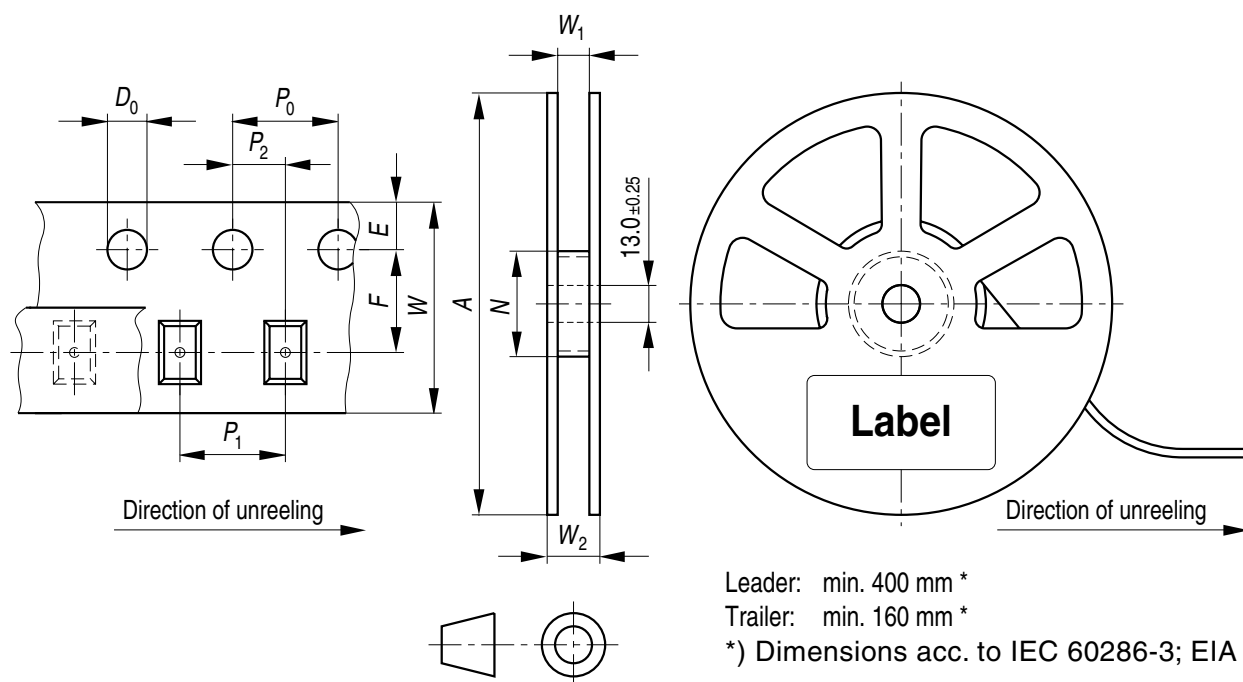

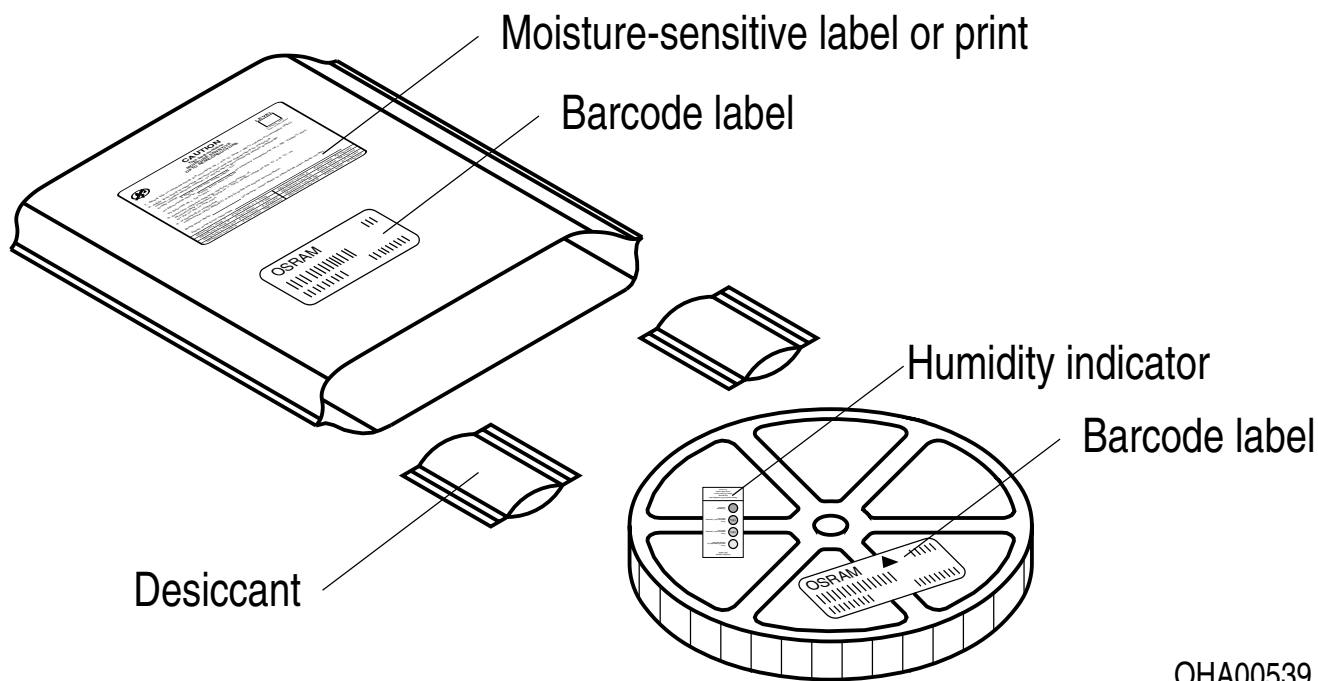

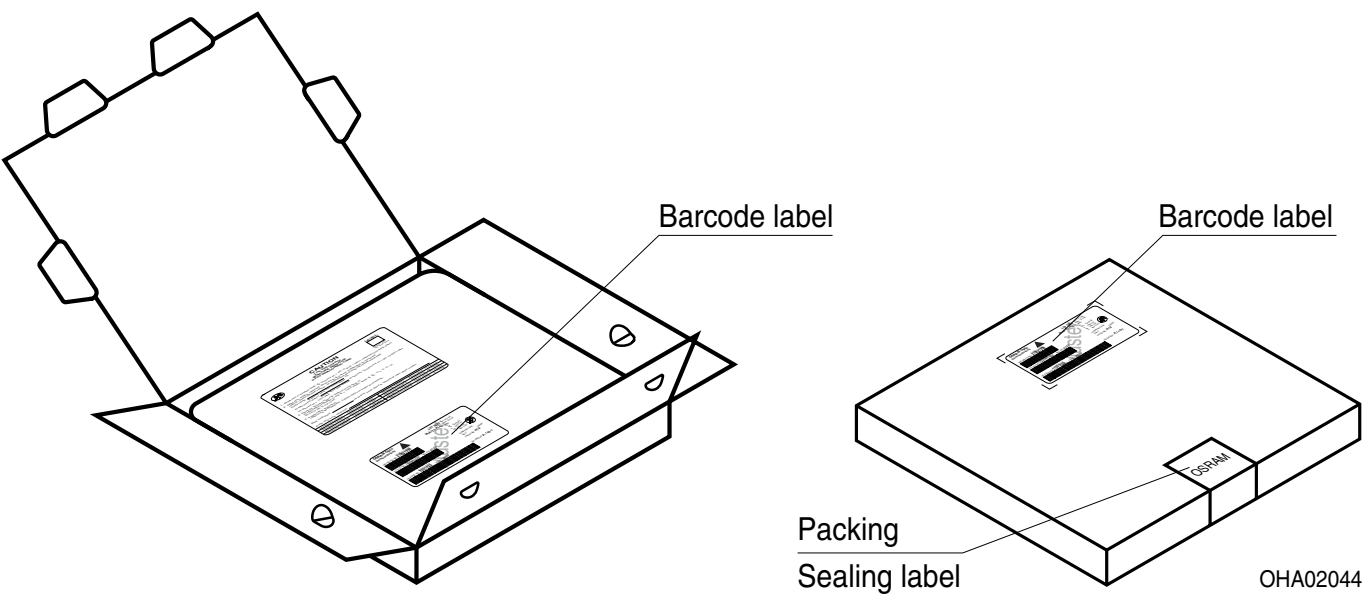

Notes
