

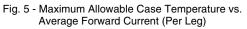



Fig. 4 - Maximum Thermal Impedance ZthJC Characteristics (Per Leg)




Fig. 7 - Maximum Non-Repetitive Surge Current (Per Leg)


