The 74AHC1G02; 74AHCT1G02 is a single 2-input NOR gate. Inputs are overvoltage tolerant. This feature allows the use of these devices as translators in mixed voltage environments.



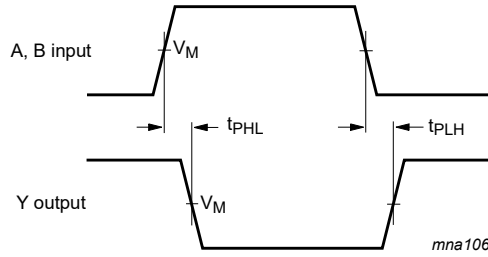

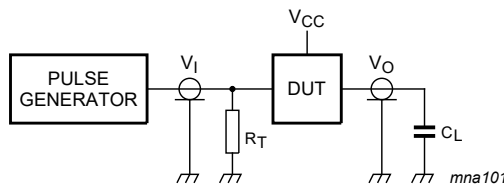

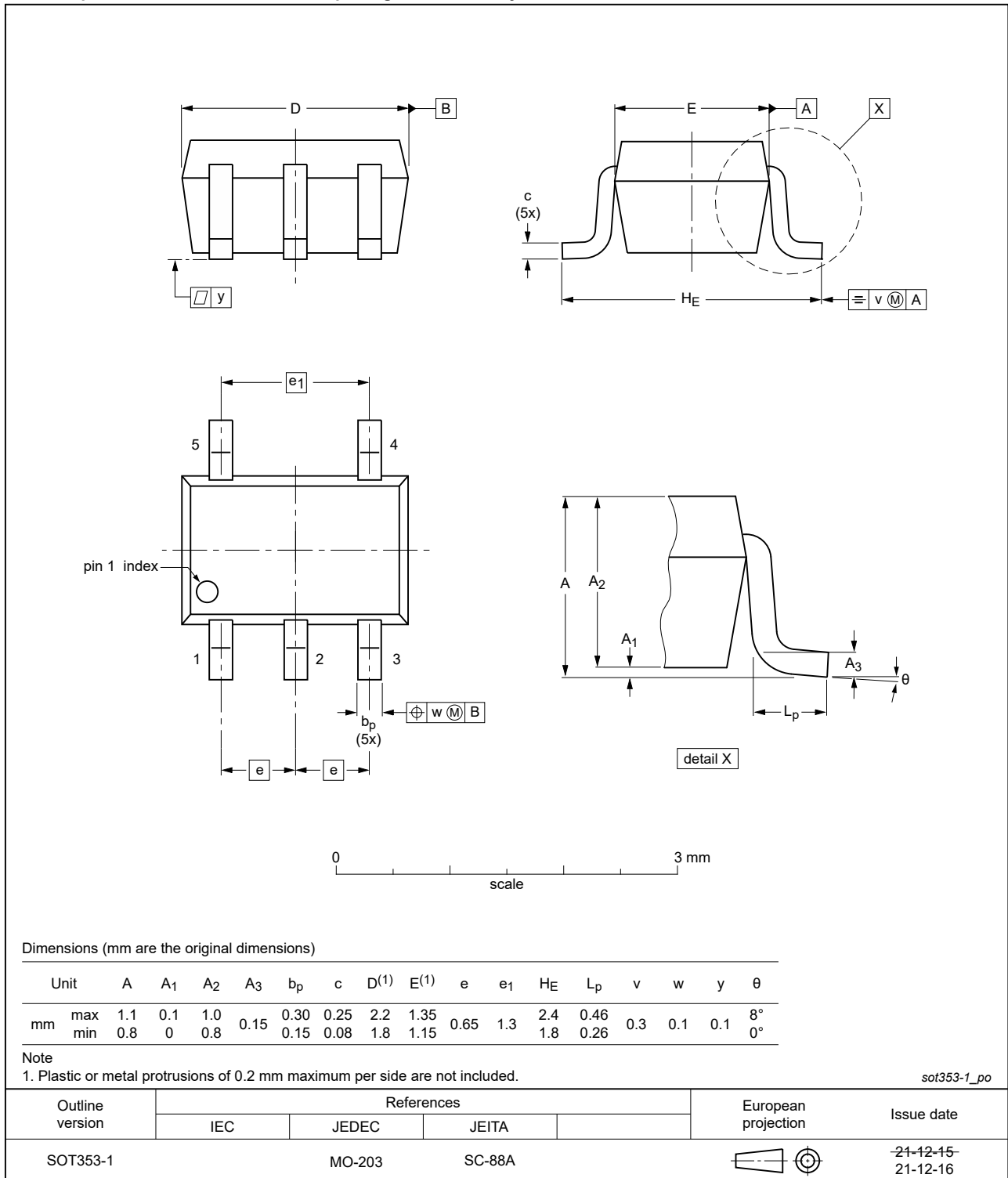


Fig. 7. Package outline SOT353-1 (TSSOP5)

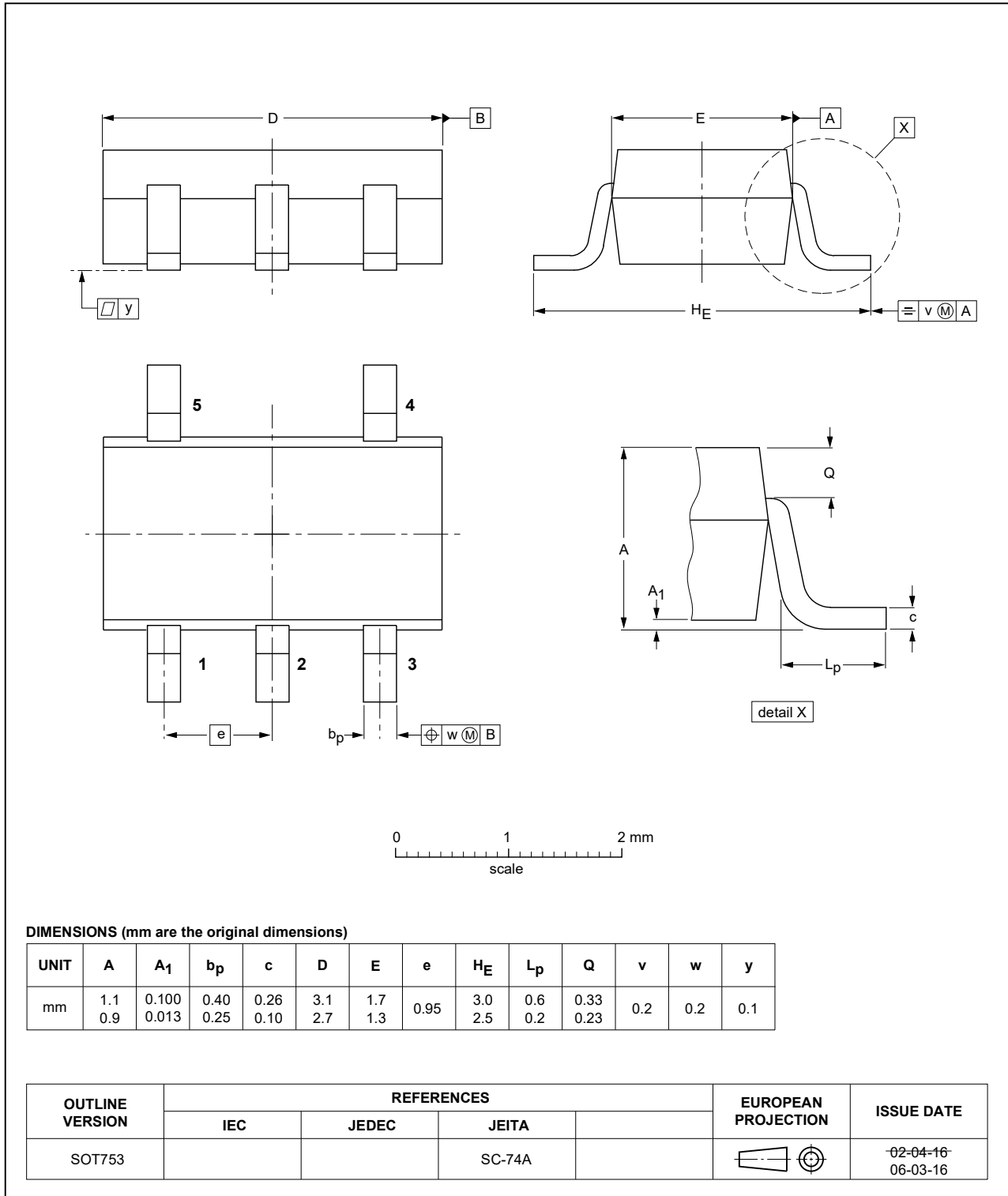


Fig. 8. Package outline SOT753 (SC-74A)
