



Features

- 1)Low collector saturation voltage, typically V_{CE(sat)}=100mV for Ic/I_B=100mA/1mA(Typ.)
- 2)High current gain, minimum h_{FE}=500mA for V_{CE}=5V, Ic=200mA
- 3)Built in Zener diode for protection against surges when connected to inductive load.

Fig.1 Ground Emitter Propagation Characteristics





Fig.2 Typical Output Characteristics

Fig.3 DC Current Gain vs. Collector Current






Fig.4 Collector-Emitter Saturation Voltage vs. Collector Current

Precaution for Mounting / Circuit board design
