
Relative Total Radiant Flux 7), 8)


Max. Permissible Forward Current



- 5) **Radiant intensity:** Measured at a solid angle of Ω = 0.01 sr
- 6) Thermal resistance: junction - soldering point, of the device only, mounted on an ideal heatsink (e.g. metal block)
