





Fig.3 DC current gain vs. collector current(I)





Fig.4 DC current gain vs. collector current(II)

Fig.5 Collector-emitter saturation voltage vs. collector current(I)





Fig.6 Collector-emitter saturation voltage vs. collector current(II)

Fig.7 Base-emitter saturation voltage vs. collector current






Fig.8 Gain bandwidth product vs. emitter current



EMITTER CURRENT : IE [mA]



Fig.9 Collector output capacitance vs. collector-base voltage




COLLECTOR-BASE VOLTAGE: V_{CB} [V]
