LDA203 is a dual unidirectional-input optocoupler with single-transistor outputs. Current transfer ratios range from 33% to 1000% with a typical value of 300%.



Board Wash


IXYS Integrated Circuits Division recommends the use of no-clean flux formulations. However, board washing to remove flux residue is acceptable. Since IXYS Integrated Circuits Division employs the use of silicone coating as an optical waveguide in many of its optically isolated products, the use of a short drying bake could be necessary if a wash is used after solder reflow processes. Chlorine- or Fluorine-based solvents or fluxes should not be used. Cleaning methods that employ ultrasonic energy should not be used.






Mechanical Dimensions




PCB Hole Pattern




