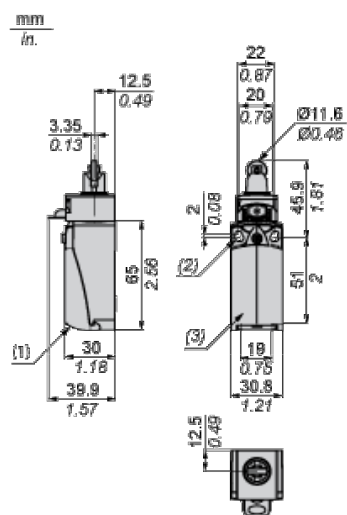

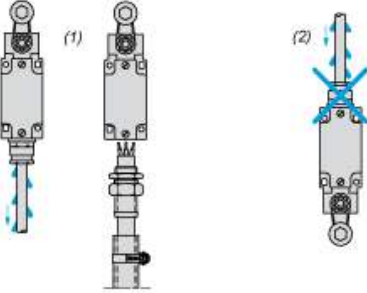
Dimensions

Mounting with Cable Entry

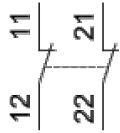
Position of Cable Gland

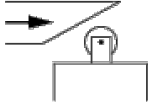
Wiring Diagrams

2-pole NC + NC Snap Action

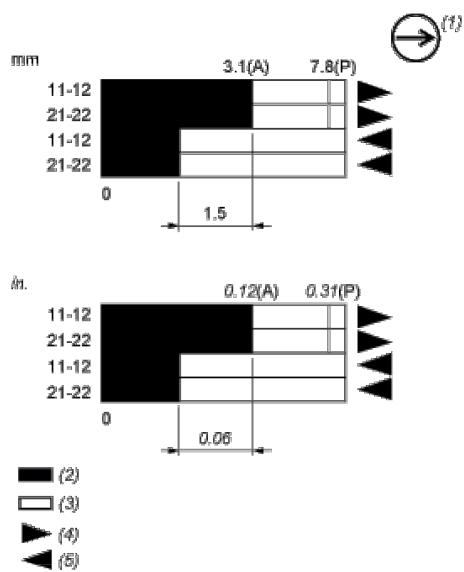


Characteristics of Actuation
