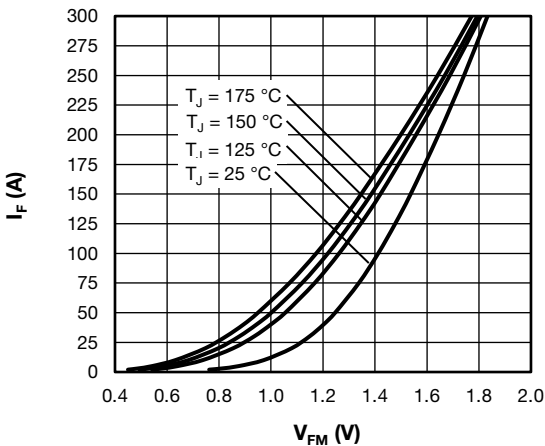


Fig. 1 - Typical Forward Voltage Drop Characteristics

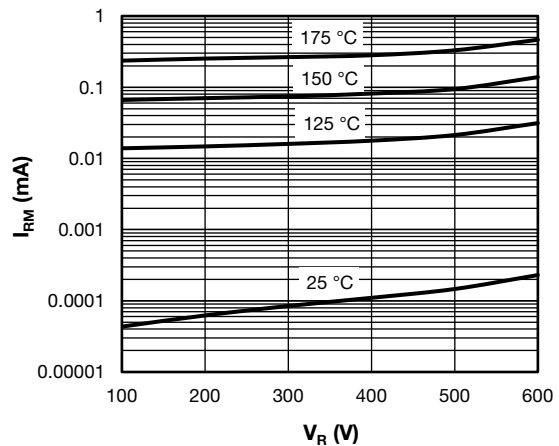


Fig. 2 - Typical Values of Reverse Current

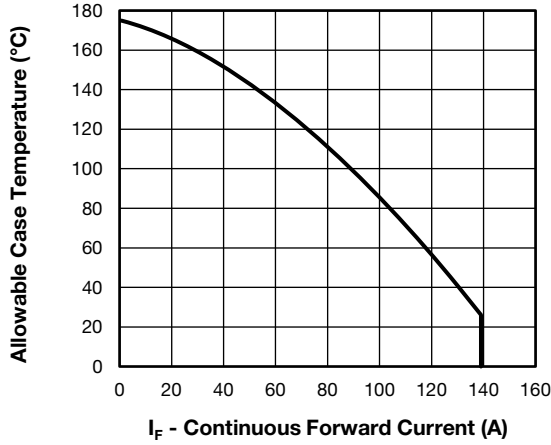


Fig. 3 - Maximum Allowable Case Temperature vs. Average Forward Current (Per Diode)

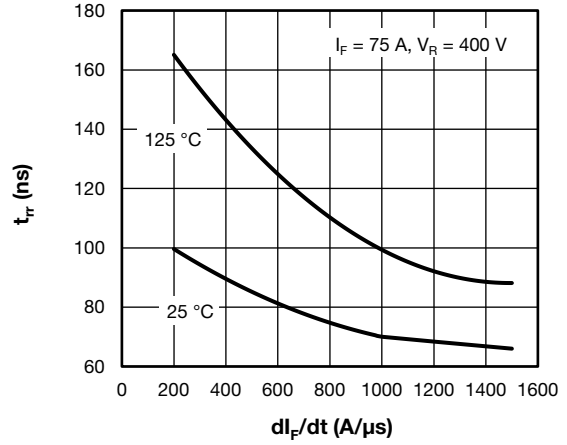


Fig. 6 - Diode Reverse Recovery Time vs. dI_F/dt

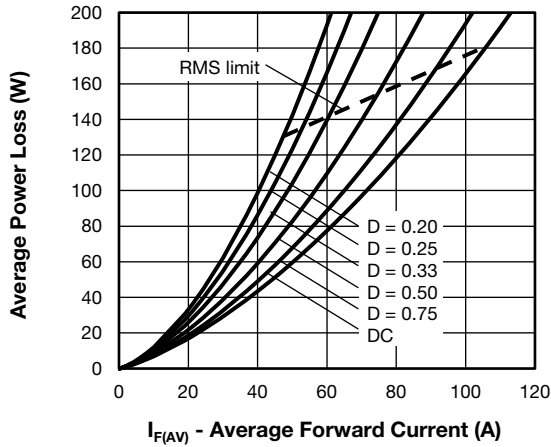


Fig. 4 - Average Power Loss vs. Average Forward Current

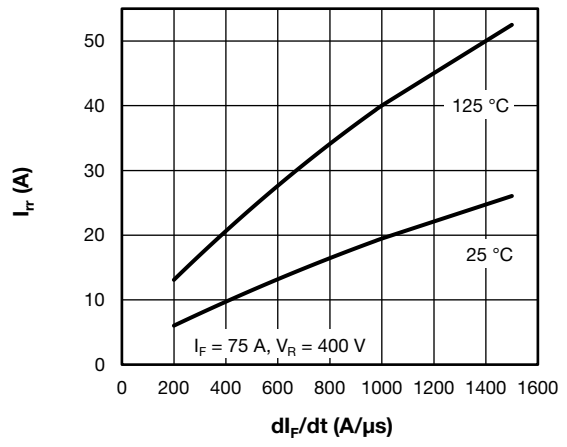


Fig. 7 - Diode Reverse Recovery Current vs. dI_F/dt

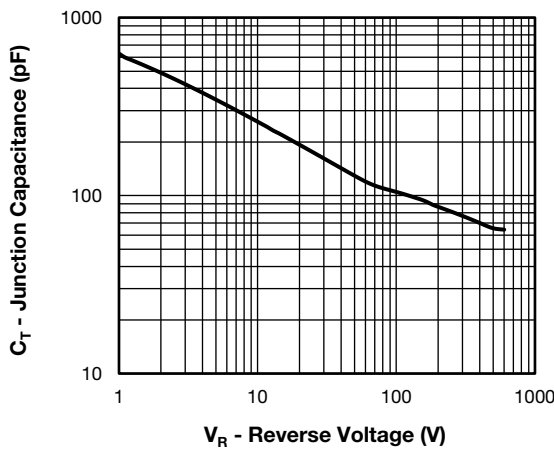


Fig. 5 - Typical Junction Capacitance vs. Reverse Voltage

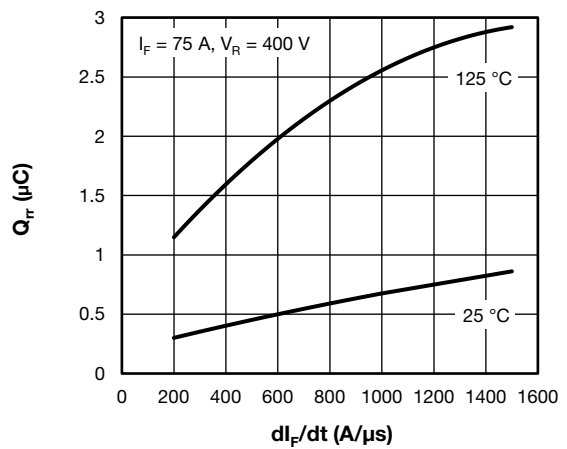


Fig. 8 - Diode Reverse Recovery Charge vs. dI_F/dt

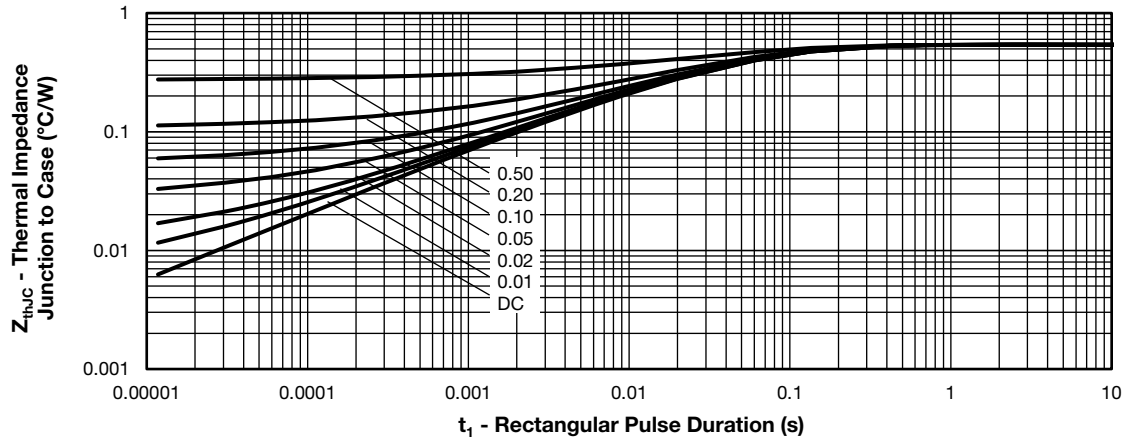


Fig. 9 - Maximum Thermal Impedance Junction to Case

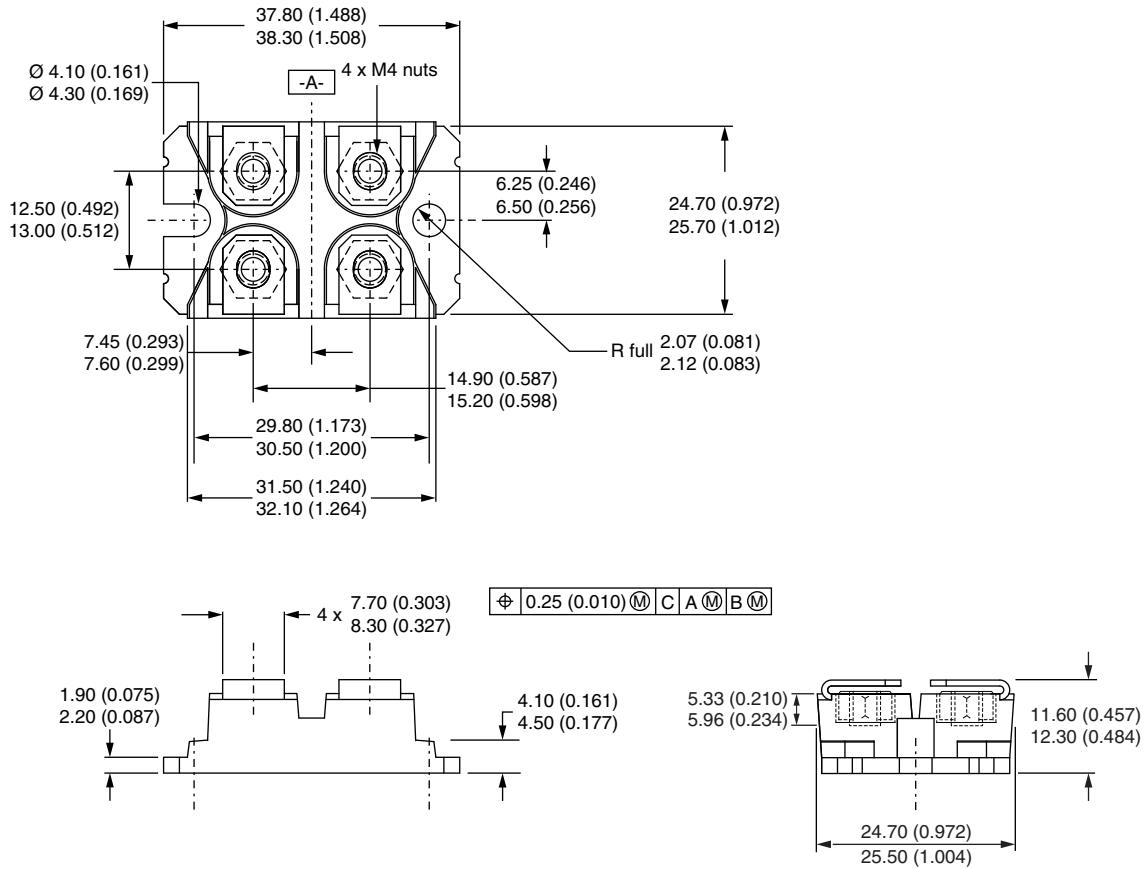
