




(1) Drain Current vs. Drain-Source Voltage




(2) Drain Current vs. Gate-Source Voltage




(3) Drain-Source On-State Resistance vs. Gate-Source Voltage (4) Drain-Source On-State Resistance vs. Ambient Temperature






(5) Drain-Source On-State Resistance vs. Drain Current

Gate-Source Voltage: V_{GS} (V)




(6) Source Current vs. Diode Forward Voltage






