


Fig.1 Ground Emitter Propagation Characteristics




Fig.2 Grounded Emitter Output

Fig.3 DC Current Gain vs. Collector Current (I)





Fig.4 DC Current Gain vs. Collector Current (II)





Fig.7 Base-Emitter Saturation Voltage

Fig.6 Collector-Emitter Saturation Voltage vs. Collector Current(II)





Fig.8 Gain Bandwith Product vs. **Emitter Current**





Fig.10 Safe Operating Area
