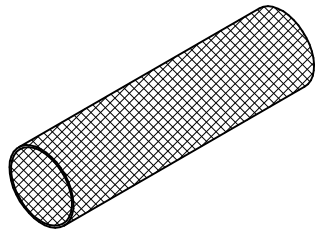
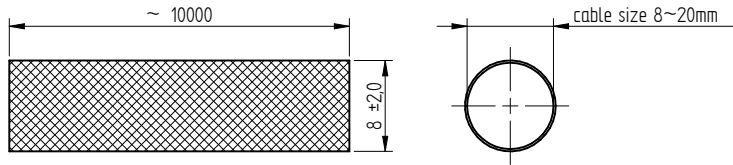

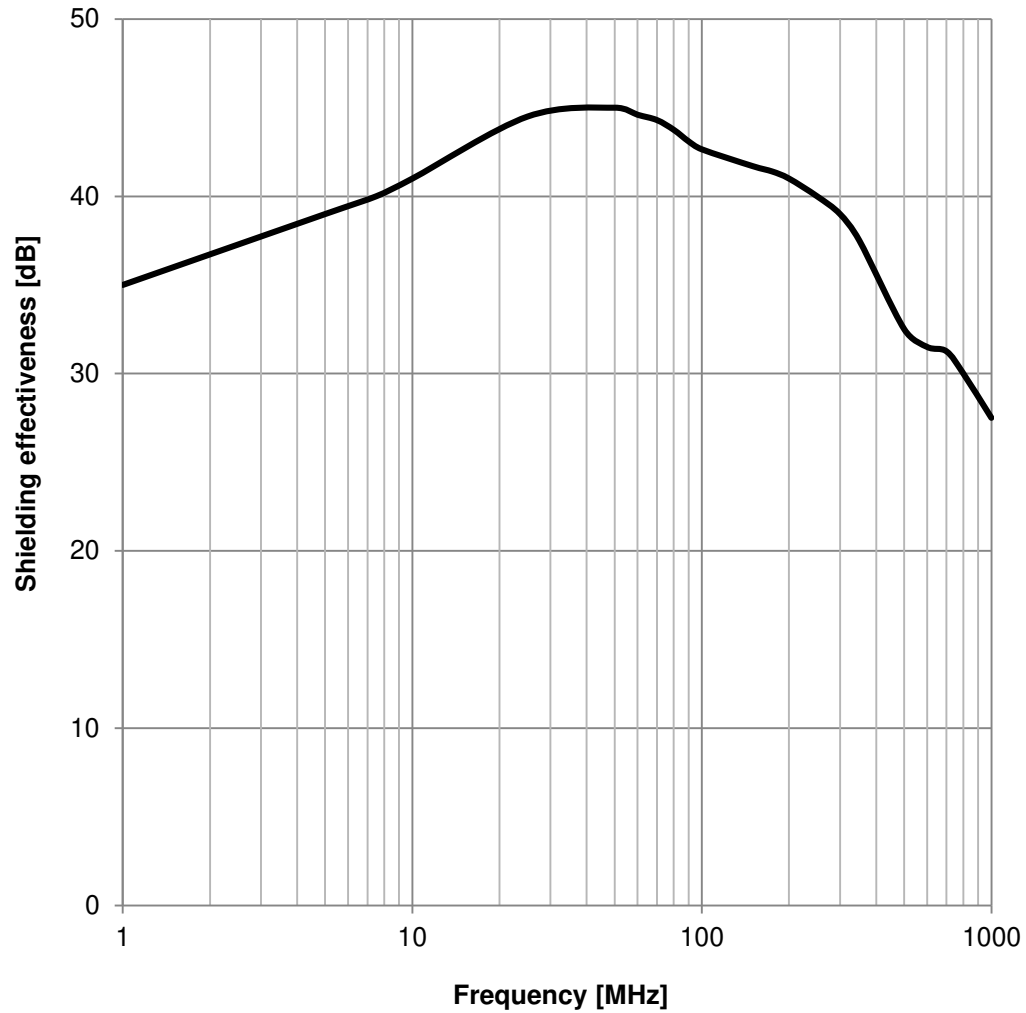

## 6. Product Life Cycle


