**DESCRIPTION**

The  $\infty$ PG2179TB is a GaAs MMIC for L, S-band SPDT (Single Pole Double Throw) switch which were developed for mobile phone and another L, S-band application. This device can operate 2 control switching by control voltage 2.5 to 5.3 V. This device can operate frequency from 0.05 to 3.0 GHz, having the low insertion loss and high isolation.

This device is housed in a 6-pin super minimold package. And this package is able to high-density surface mounting.

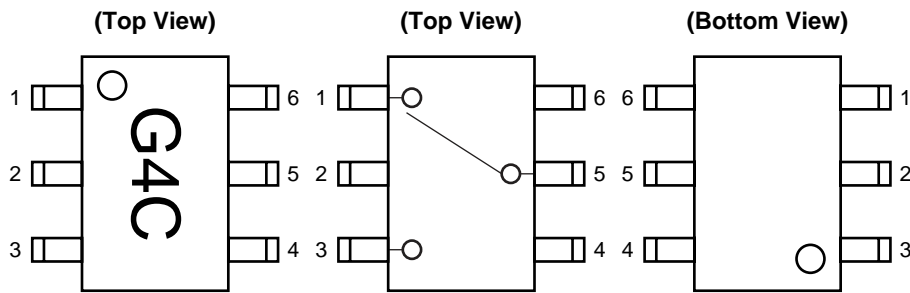

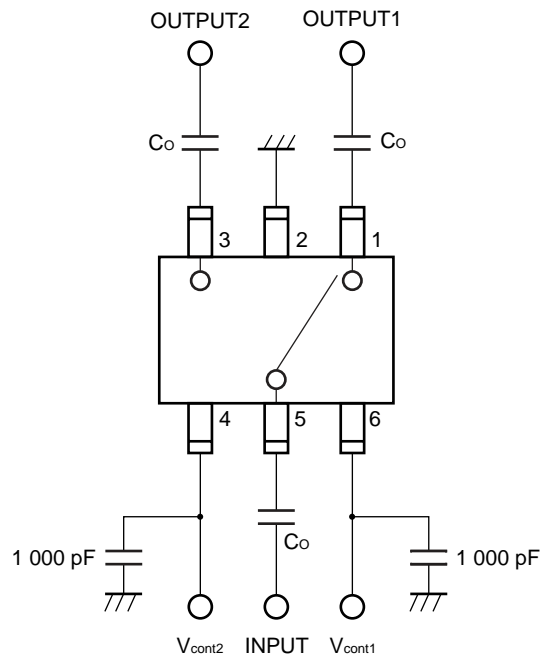

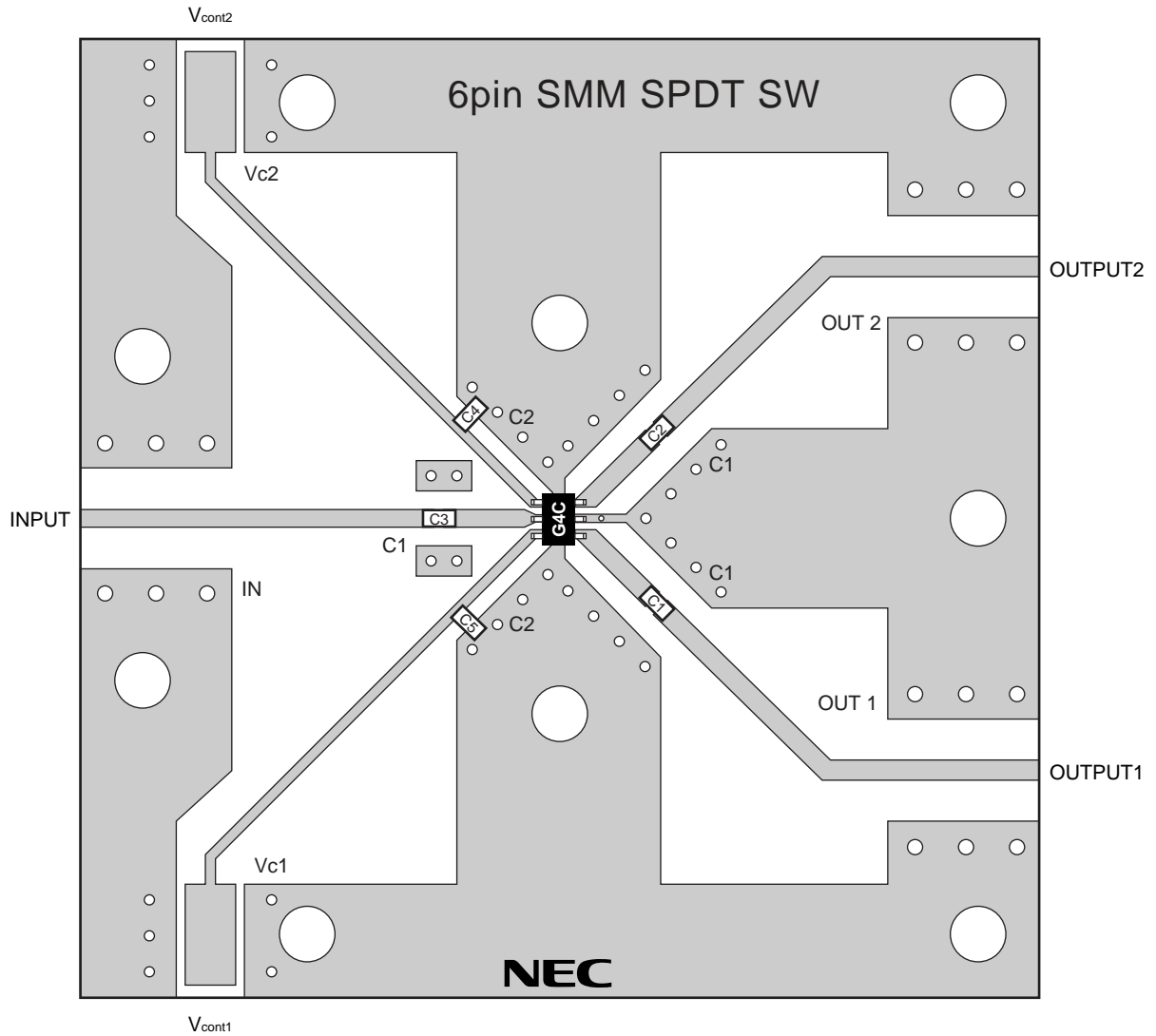

★ ILLUSTRATION OF THE TEST CIRCUIT ASSEMBLED ON EVALUATION BOARD



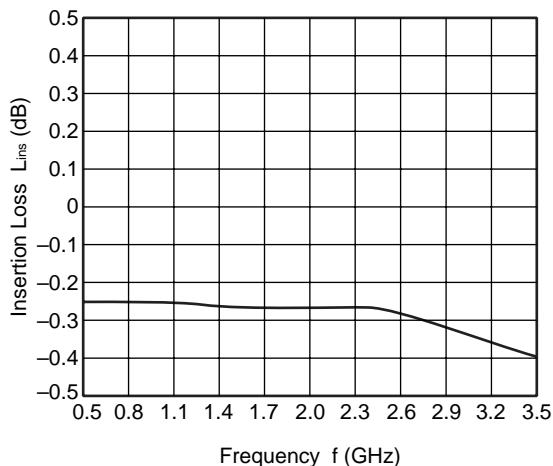

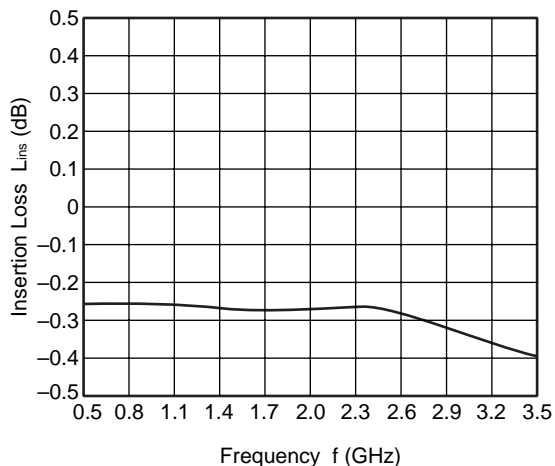

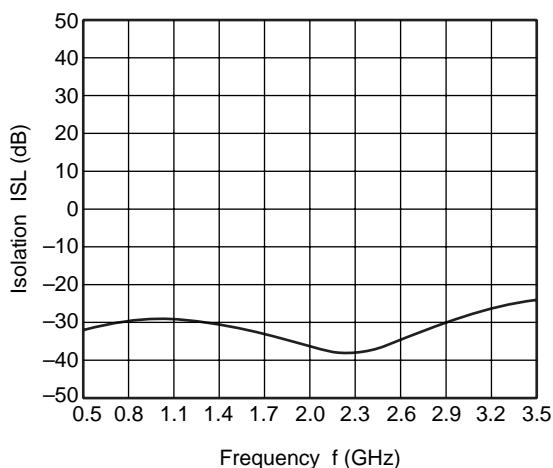

INSERTION LOSS vs. FREQUENCY



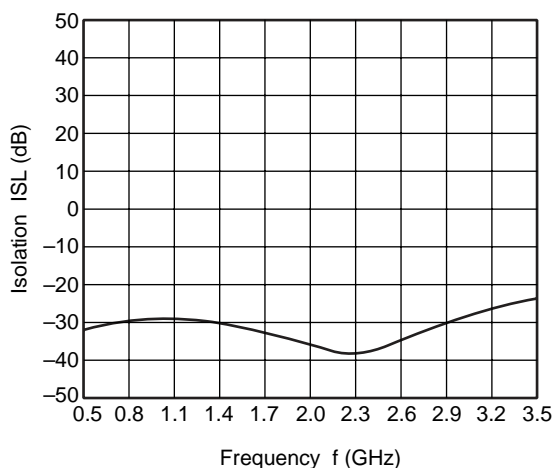
INPUT-OUTPUT2  
INSERTION LOSS vs. FREQUENCY



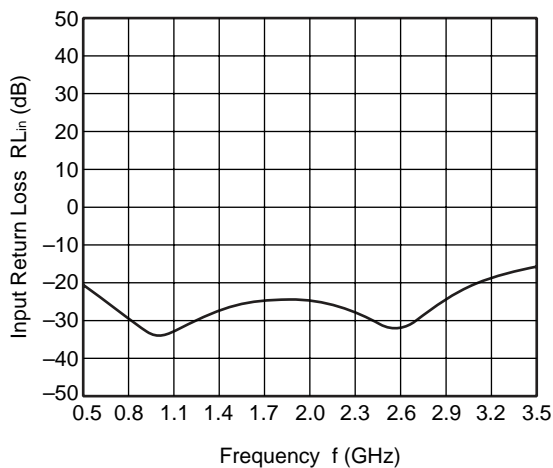
INPUT-OUTPUT1  
ISOLATION vs. FREQUENCY



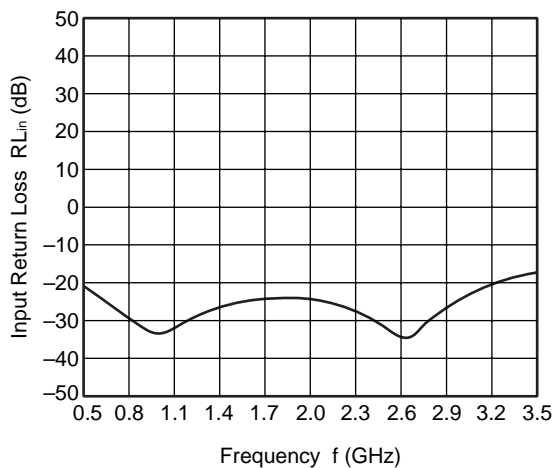
INPUT-OUTPUT2

INPUT RETURN LOSS vs. FREQUENCY

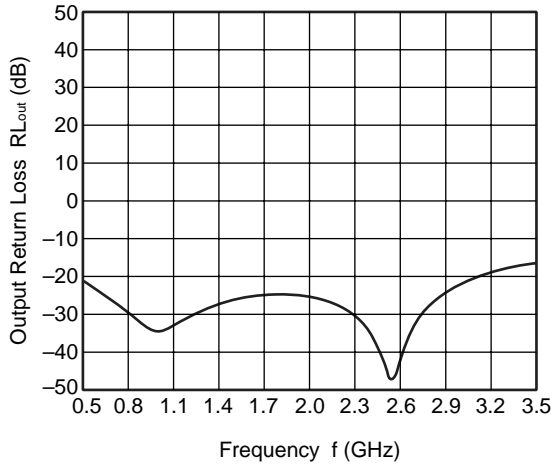

INPUT RETURN LOSS vs. FREQUENCY

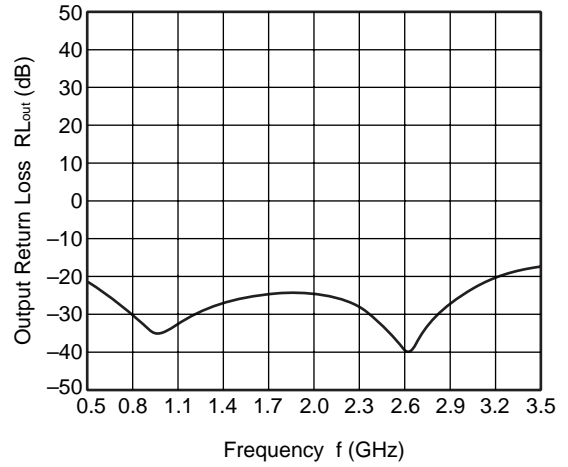

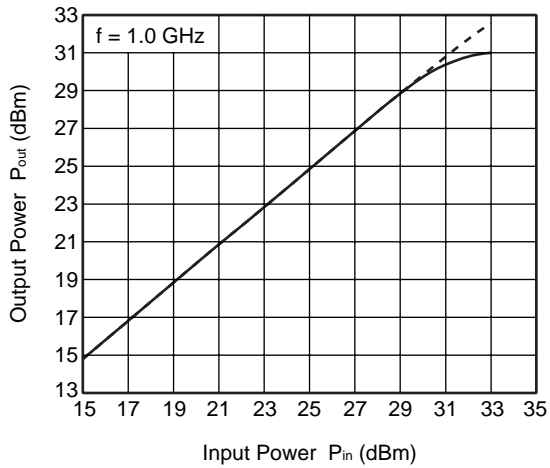

OUTPUT RETURN LOSS vs. FREQUENCY



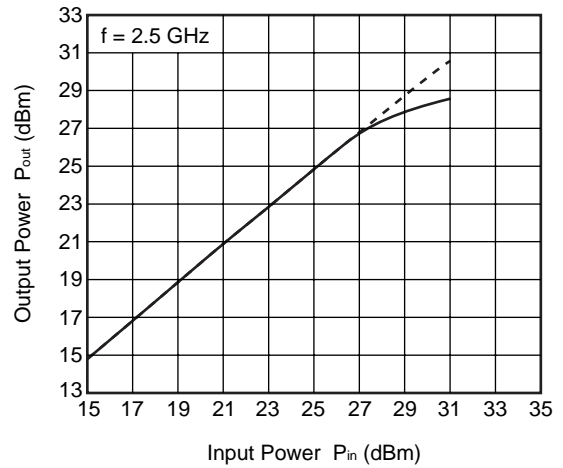
INPUT-OUTPUT2

OUTPUT POWER vs. INPUT POWER



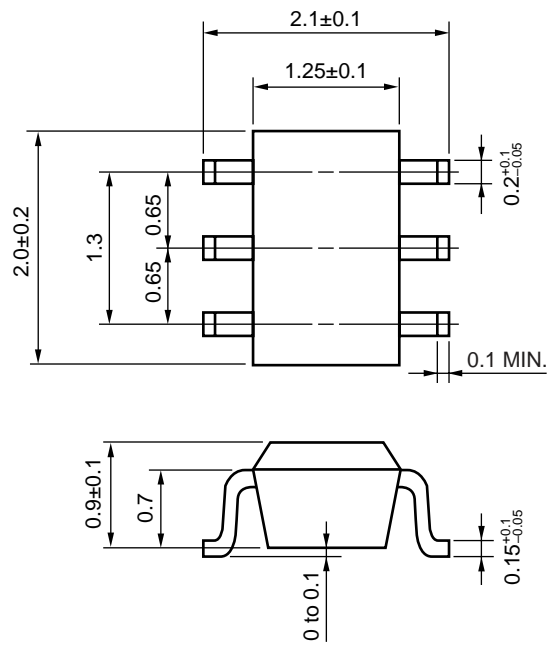
OUTPUT POWER vs. INPUT POWER
