









Recommended Hole Pattern: [mm]

General:

This electronic component is designed and manufactured for use in general electronic equipment. Würth Elektronik does not warrant any customer qualified product characteristics beyond Würth Elektroniks' specifications, for its validity and sustainability over time. The responsibility for the applicability of the customer specific products and use in a particular customer design is always within the authority of the customer. All technical specifications for standard products also apply to customer specific products.

Product specific:

Soldering:

The solder profile must comply with the technical product specifications. All other profiles will void the warranty. All other soldering methods are at the customers' own risk.

Cleaning and Washing:

Washing agents used during the production to clean the customer application might damage or change the characteristics of the wire insulation, marking or plating. Washing agents may have a negative effect on the long-term functionality of the product.

Potting:

If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. Shrinking could lead to an incomplete seal, allowing contaminants into the core. Expansion could damage the component. We recommend a manual inspection after potting to avoid these effects.

Storage Conditions:

A storage of Würth Elektronik products for longer than 12 months is not recommended. Within other effects, the terminals may suffer degradation, resulting in bad solderability. Therefore, all products shall be used within the period of 12 months based on the day of shipment. Do not expose the components to direct sunlight. The storage conditions in the original packaging are defined according to DIN EN 61760-2. The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.

Packaging:

The packaging specifications apply only to purchase orders comprising whole packaging units. If the ordered quantity exceeds or is lower than the specified packaging unit, packaging in accordance with the packaging specifications cannot be ensured.

Handling:

Violation of the technical product specifications such as exceeding the nominal rated current will void the warranty.
