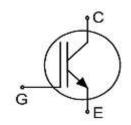


Further Electrical Characteristics
