

Inner circuit






Fig.1 Ground Emitter Propagation Characteristics




Fig.2 Typical Output Characteristics




Fig.7 Base-Emitter Saturation Voltage vs. Collector Current






Fig.8 Gain Bandwidth Product vs. Emitter Current





