



Fig.2 Typical Output Characteristics

Fig.3 DC Current Gain vs. Collector Current (I)





Fig.4 DC Current Gain vs. Collector

Voltage vs. Collector Current (I)





Fig.6 Collector-Emitter Saturation

Fig.7 Base-Emitter Saturation Voltage vs. Collector Current





Fig.8 Gain Bandwidth Product vs.

Collector Output Capacitance vs. Collector-Base Voltage




Fig.10 Safe Operating Area






Fig.11 Safe Operating Area


