






Polarity mark




SPATIAL DISTRIBUTION



SUPER BRIGHT YELLOW




REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS





TAPE SPECIFICATIONS (units : mm)




REEL DIMENSION (units : mm)
