

DESCRIPTION

This triple inverter is designed for 1.65-V to 5.5-V V_{CC} operation. The SN74LVC3G04 device performs the Boolean function Y = A.

NanoFree™ package technology is a major breakthrough in IC packaging concepts, using the die as the package.

This device is fully specified for partial-power-down applications using I_{off} . The I_{off} circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.



DIE SIZE BALL GRID ARRAY



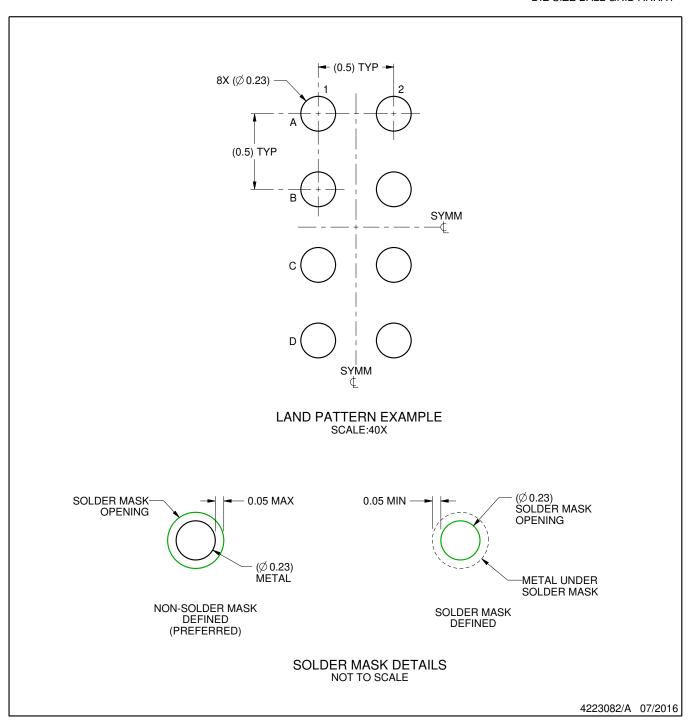

DIE SIZE BALL GRID ARRAY

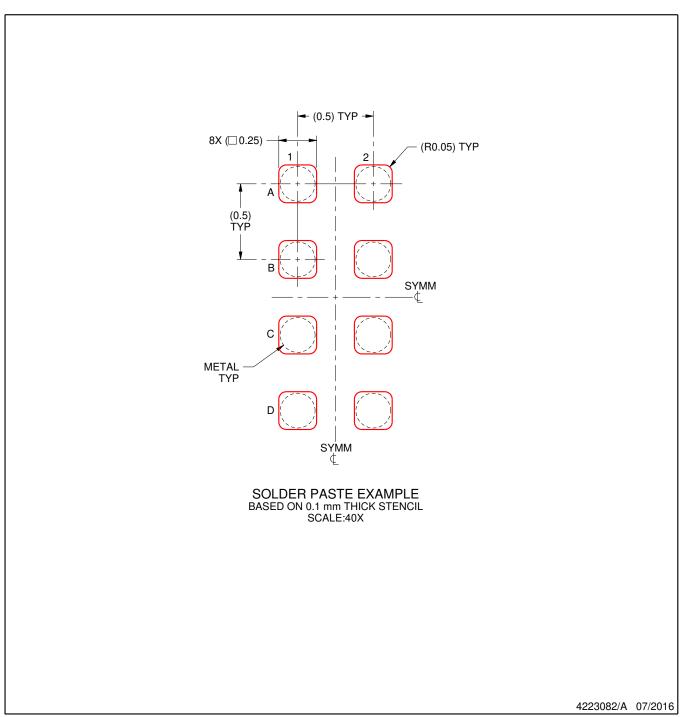

DIE SIZE BALL GRID ARRAY

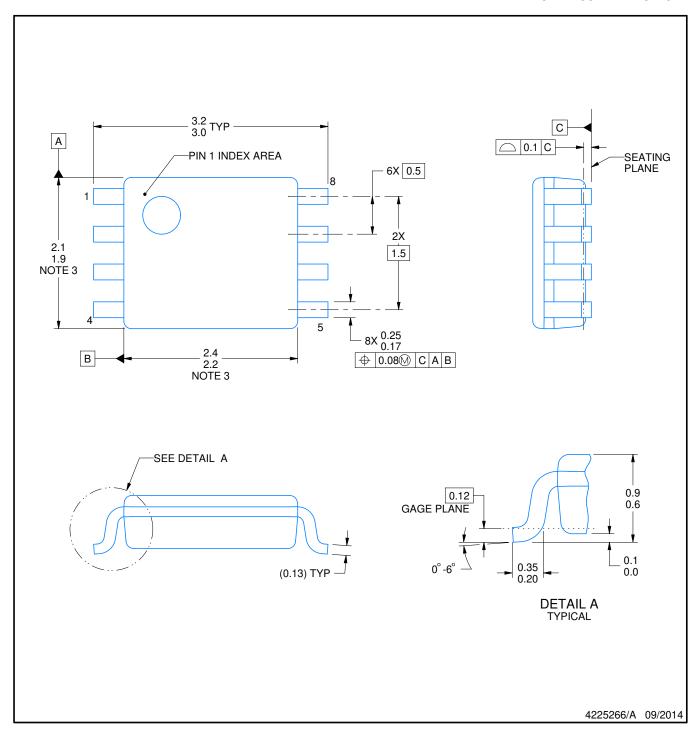
