







Fig.4 DC Current Gain vs. Collector Current (II)




Fig.6 Collector-Emitter Saturation Voltage vs. Collector Current (II)




Fig.7 Base-Emitter Saturation Voltage vs. Collector Current







Fig.8 Gain Bandwidth Product vs. Emitter Current




## Fig.9 Capacitance vs. Reverse Bias Voltage






# Fig.11 Noise factor vs.collector current characteristics
