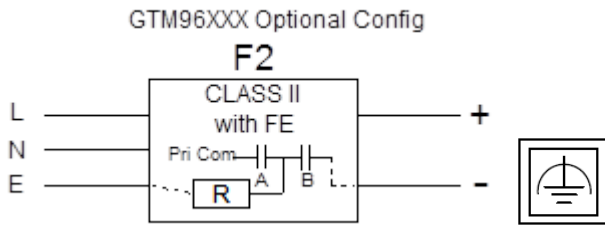

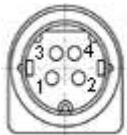

Pin 2,4: +V, Pin 1,3, Shell: -V



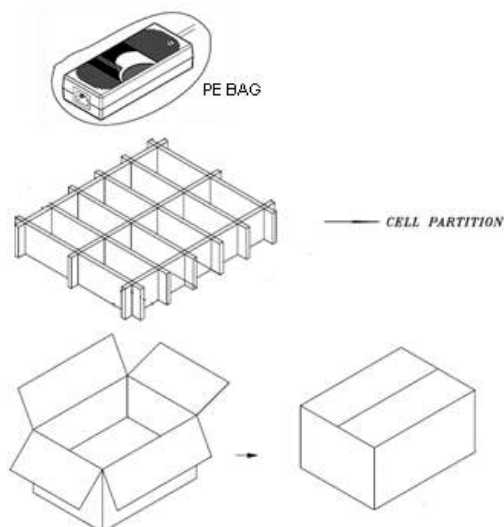
