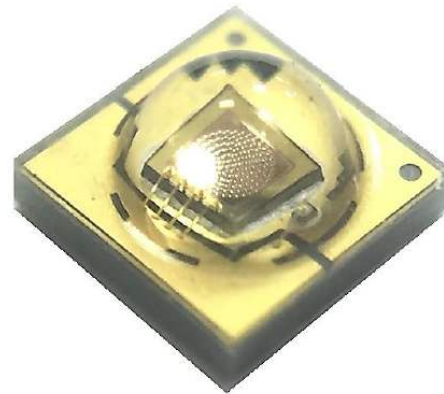

(Suggest Stencil t=0.12 mm)

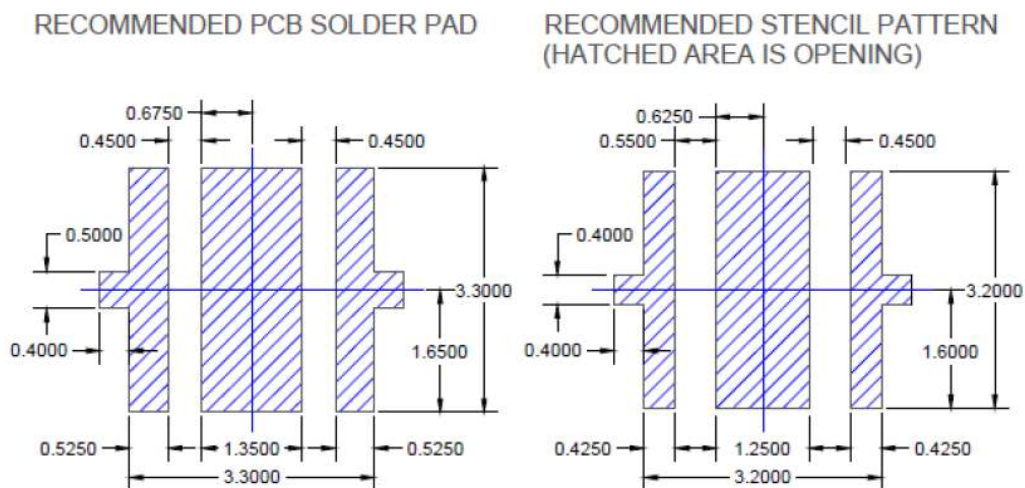
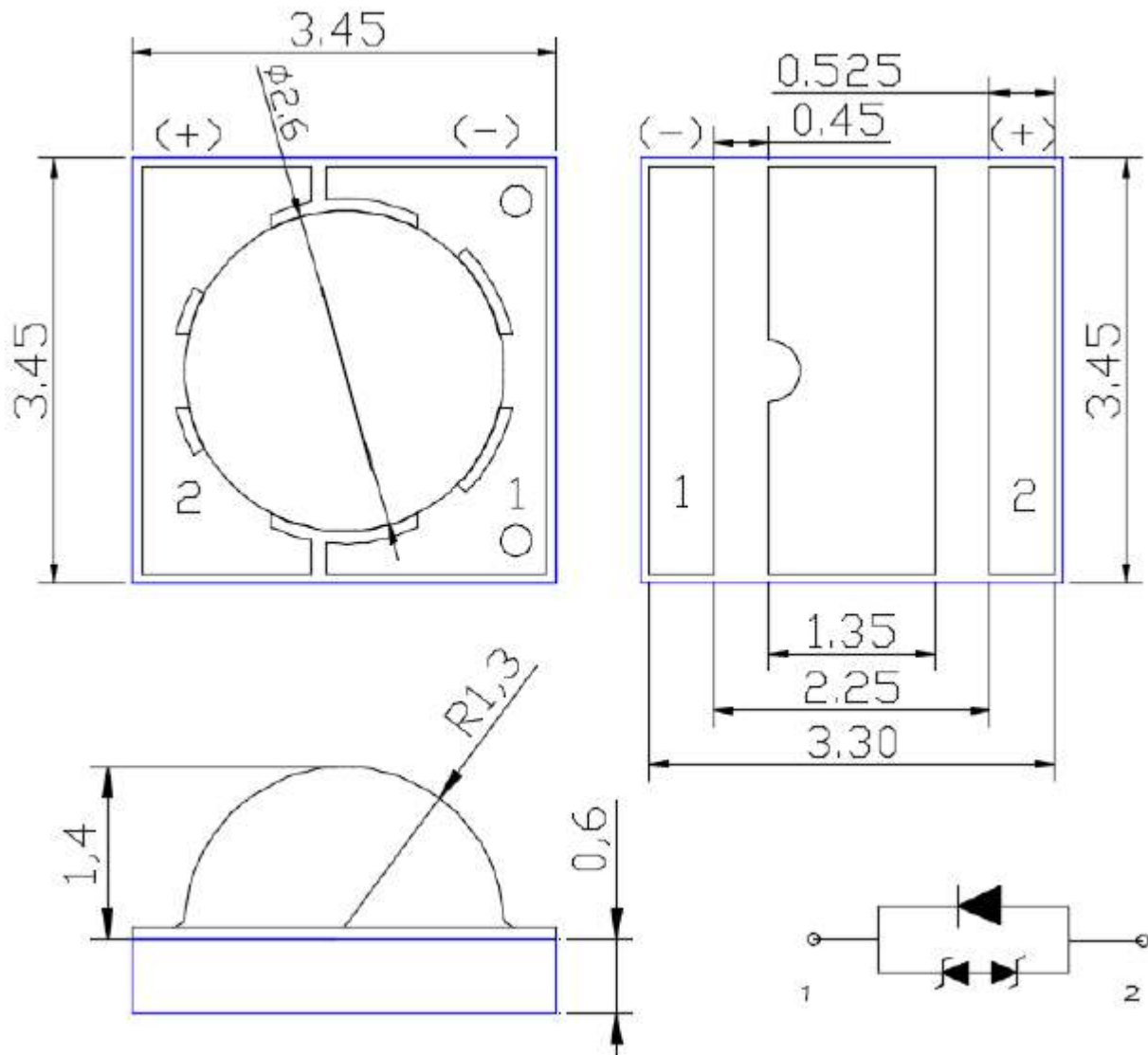


Figure 1. INV-C33CTOHIR Recommended Solder Pattern

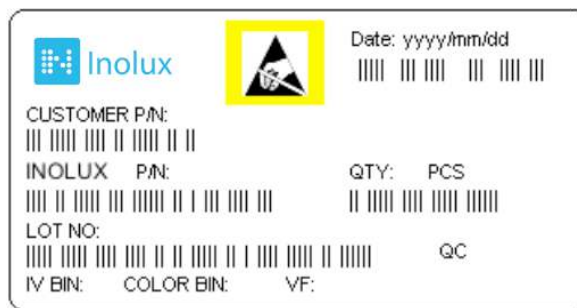

Forward Current VS. Forward Voltage

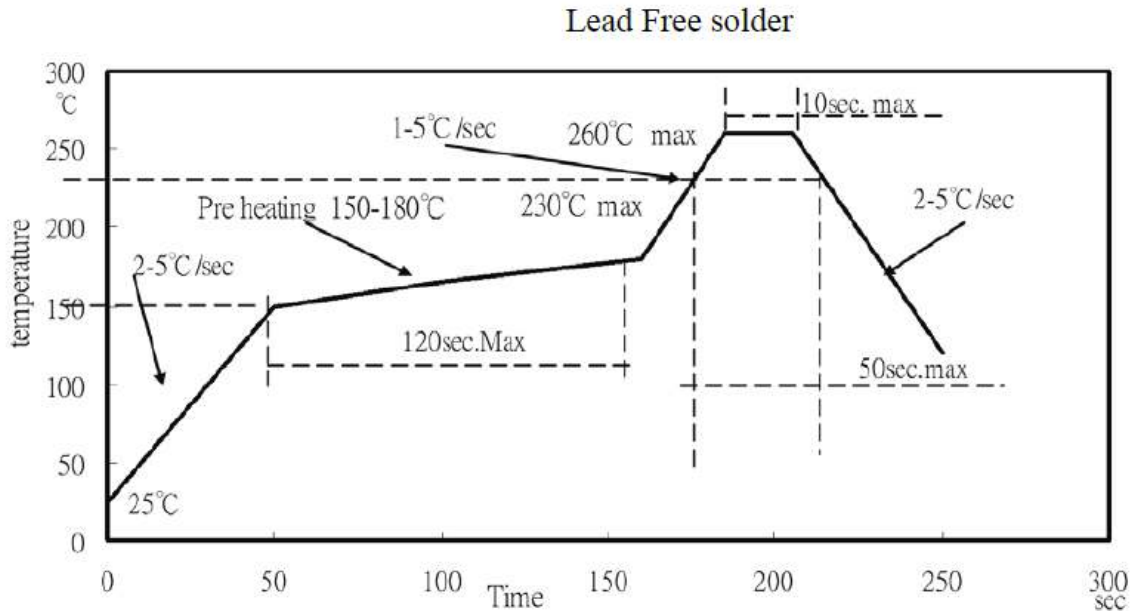

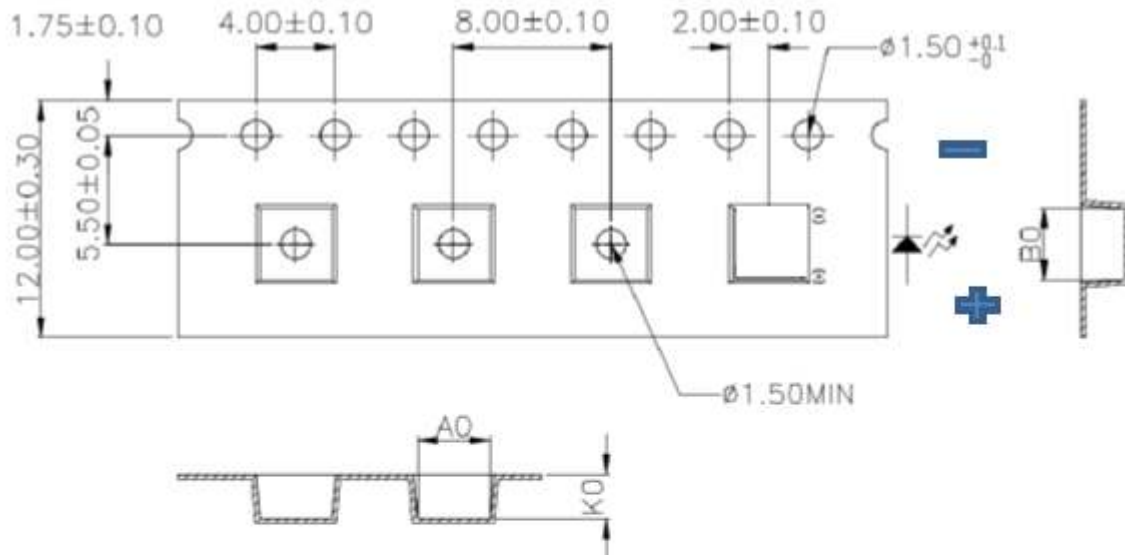
Rework

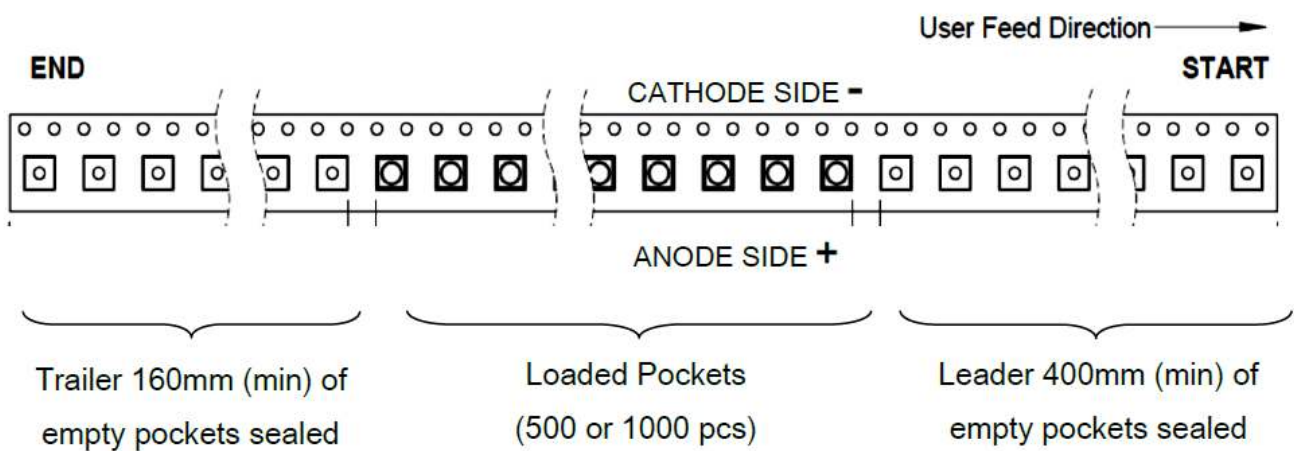
1. Do not stress the silicone resin while it is exposed to high temperature.
2. The number of reflow process should not exceed 3 times.

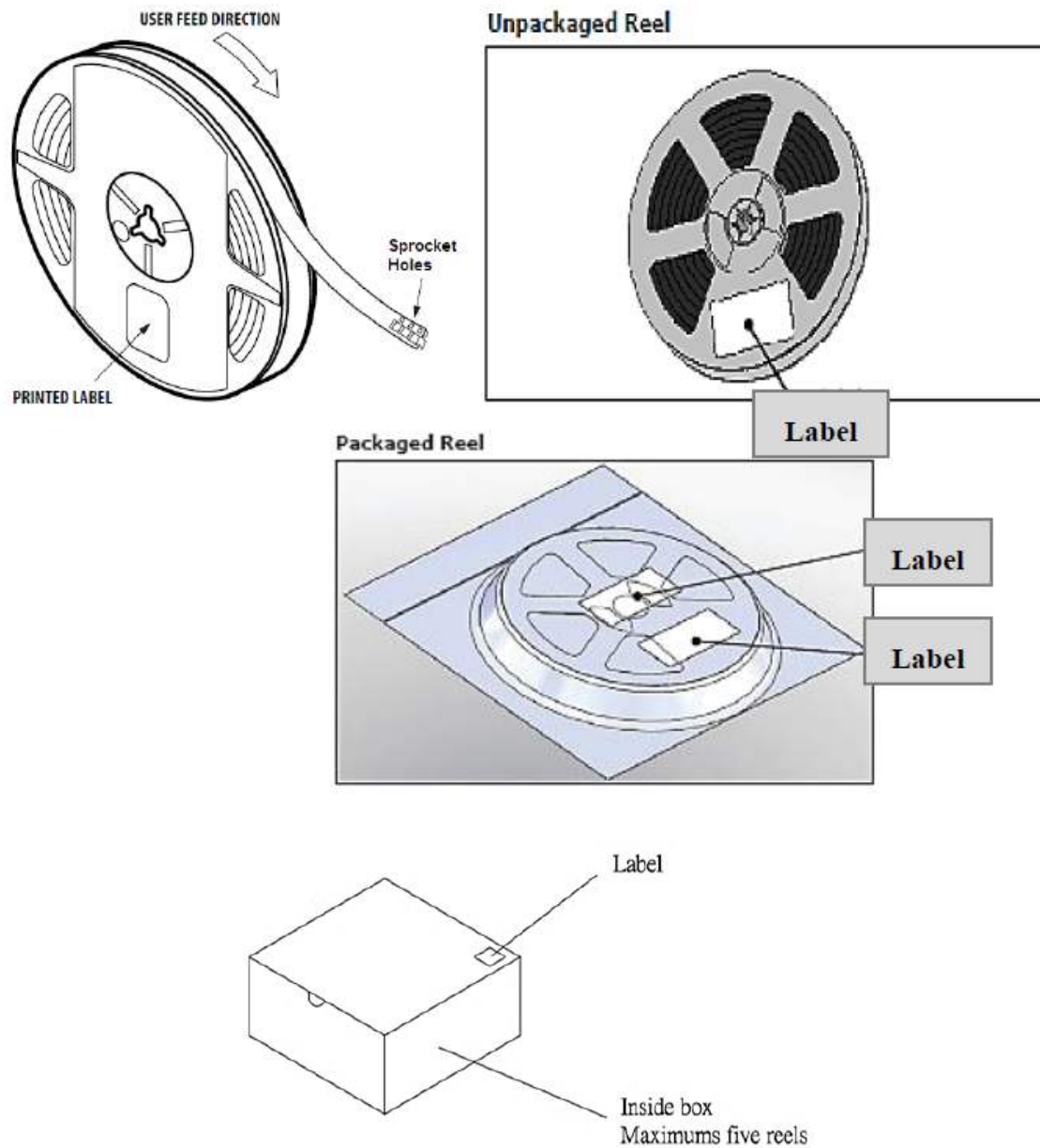
