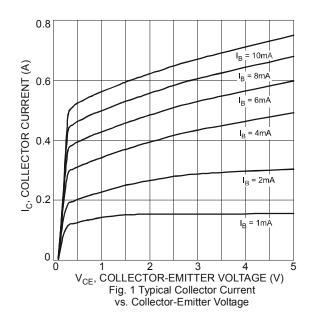
Derating Curve

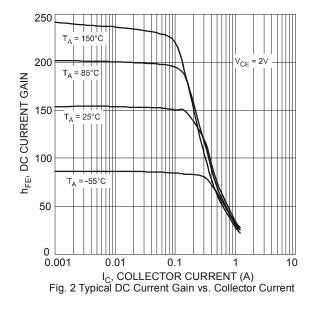
