



Fig.1 Grounded emitter propagation characteristics





Fig.2 Grounded emitter output characteristics

Fig.3 DC current gain vs. collector current (I)





Fig.4 DC current gain vs. collector current (II)

Fig.5 Collector- emitter saturation voltage vs. collector current (I)




Fig.6 Collector- emitter saturation voltage vs. collector current (II)




Fig.7 Base- emitter saturation voltage vs. collector current






Fig.8 Gain bandwidth product vs. emitter current

Fig.1 Input Voltage vs. Output Current (ON Characteristics)




Fig.2 Output Current vs. Input Voltage (OFF Characteristics)




Fig.3 Output Current vs. Output Voltage





Fig.4 DC Current Gain vs. Output Current




DC CURRENT GAIN: G


Fig.5 Output Voltage vs. Output Current
