



TEST CIRCUIT 2 SWITCHING TIME










★ FORWARD BIAS SAFE OPERATING AREA




TRANSIENT THERMAL RESISTANCE vs. PULSE WIDTH










FORWARD TRANSFER ADMITTANCE vs. DRAIN CURRENT







DRAIN TO SOURCE ON-STATE RESISTANCE vs. GATE TO SOURCE VOLTAGE







DRAIN TO SOURCE ON-STATE RESISTANCE vs. CHANNEL TEMPERATURE






CAPACITANCE vs. DRAIN TO SOURCE VOLTAGE




VDS - Drain to Source Voltage - V




SOURCE TO DRAIN DIODE FORWARD VOLTAGE



V_{F(S-D)} - Source to Drain Voltage - V


REVERSE RECOVERY TIME vs. DIODE FORWARD CURRENT








SINGLE AVALANCHE ENERGY DERATING FACTOR




Starting T_{ch} - Starting Channel Temperature - ${}^{\circ}C$
