



Fig.1 Grounded Emitter Propagation






Fig.2 Grounded Emitter Output Characteristics




COLLECTOR TO EMITTER VOLTAGE : V_{CE} [V]

Fig.4 Collector-Emitter Saturation Voltage vs. Collector Current


