

## **Switching Characteristics Test Circuit**




## I<sub>CC (opr)</sub> Test Circuit

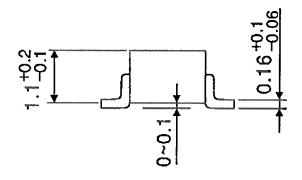


Input waveform is the same as that in case of switching characteristics test.





