





FIG.1 FORWARD CURRENT DERATING CURVE





FIG.2 NON-REPETITIVE PEAK SURGE FORWARD **CURRENT** 180 PEAK FORWARD SURGE CURRENT,(A) 160 Half sine-wave 140 120 $T_J = 25^{\circ}C$ 100 80 $T_{J} = 125^{\circ}C$ 60 40 20 0






FIG.5 TYPICAL REVERSE CHARACTERISTICS








TOTAL CAPACITIVE CHARGE, (nC)
