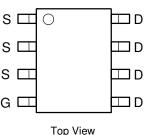

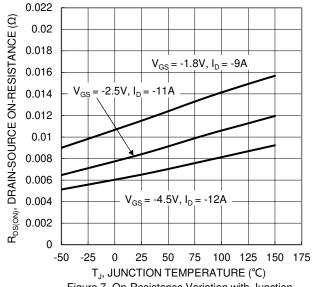


Figure 7. On-Resistance Variation with Junction Temperature

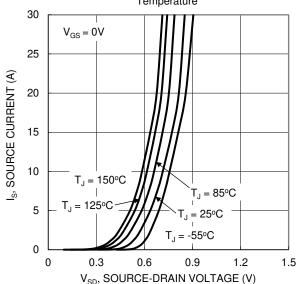


Figure 9. Diode Forward Voltage vs. Current 10 8 6 $V_{GS}(V)$ 4 $V_{DS} = -10V, I_{D} = -12A$ 2 0 0 25 50 75 100 125 150 175 Q_g (nC) Figure 11. Gate Charge

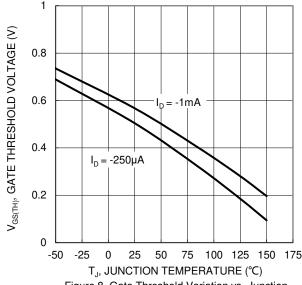
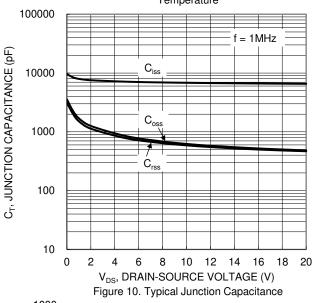


Figure 8. Gate Threshold Variation vs. Junction Temperature

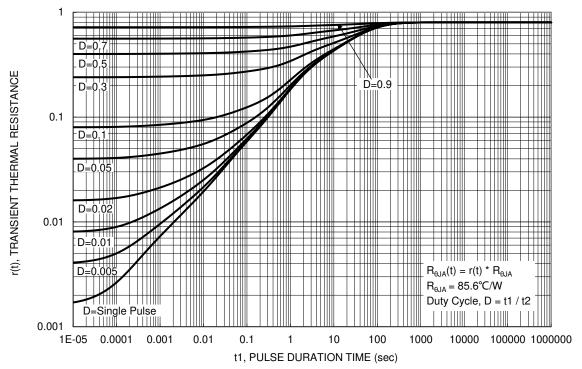


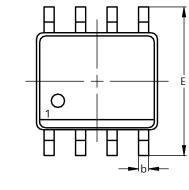
Figure 13. Transient Thermal Resistance

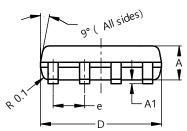


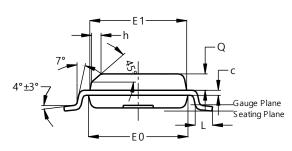

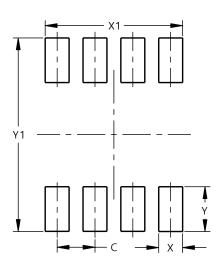
