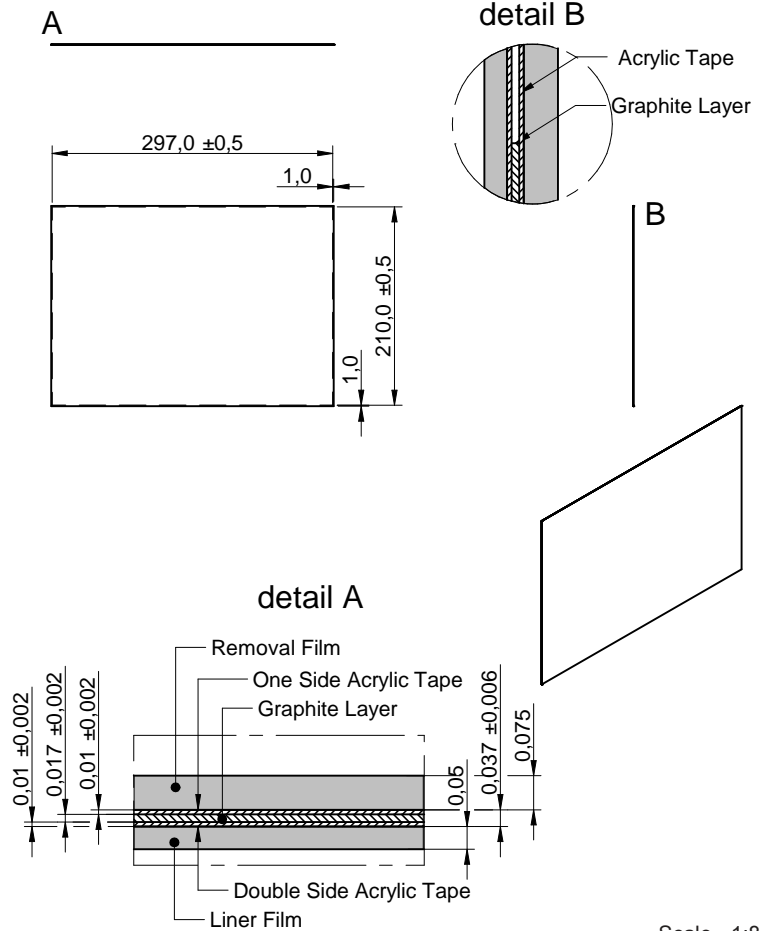

Product Specific:

Cleaning and Washing:

- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the+- components.




Packaging:

Handling:

- This product cannot ensure insulation due to the risk of powder falling off conductive materials.


