

Fig.3 DC Current Gain vs. Collector Current (I)













# • Electrical characteristic curves( $T_a = 25^{\circ}C$ )



# Fig.7 Base-Emitter Saturation Voltage vs. Collector Current




# Fig.8 Gain Bandwidth Product vs. Emitter Current


