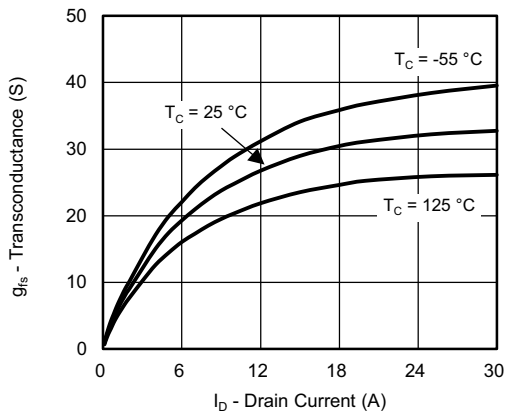

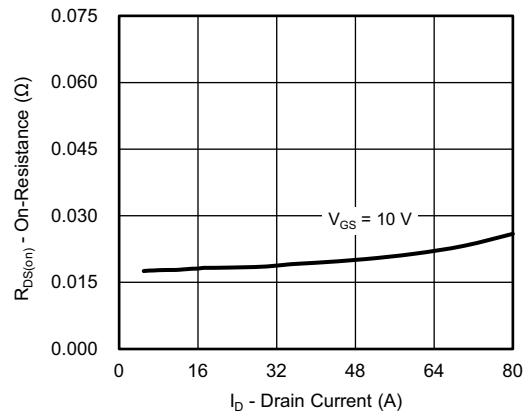

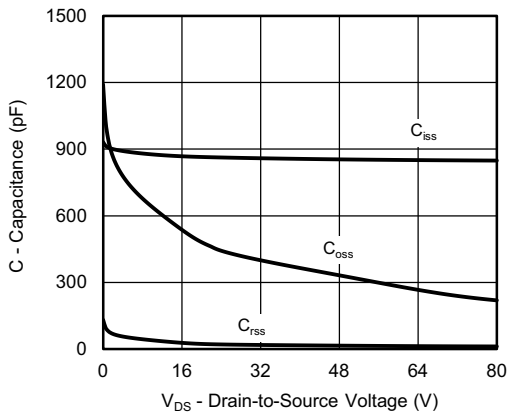
Transfer Characteristics



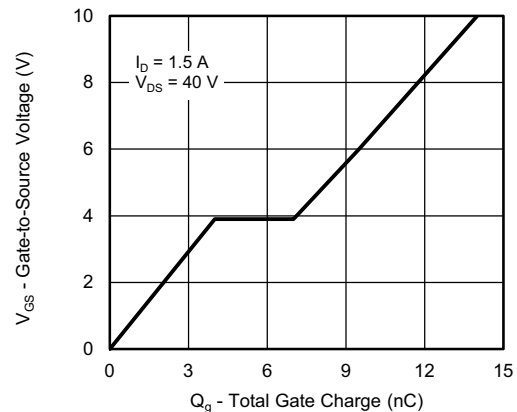
Transconductance



On-Resistance vs. Drain Current



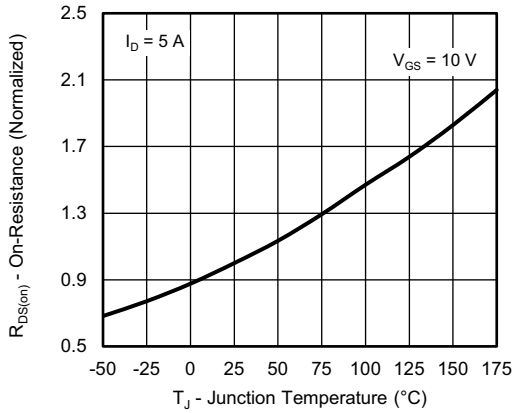

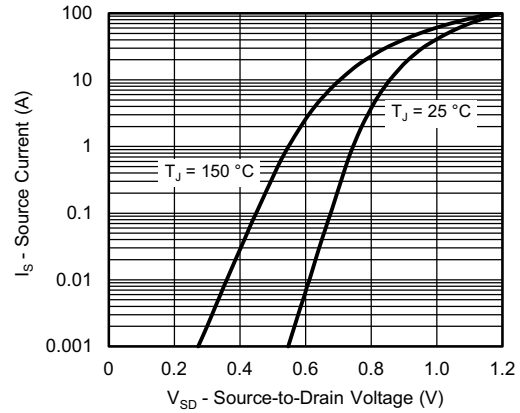

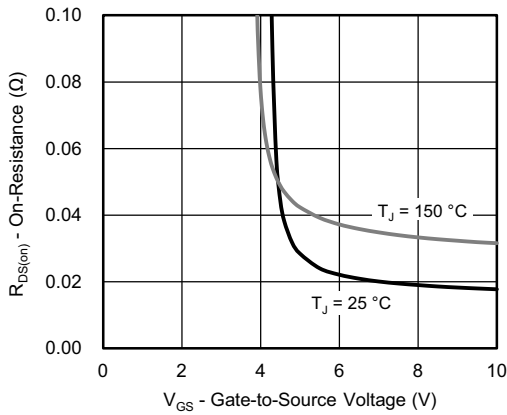

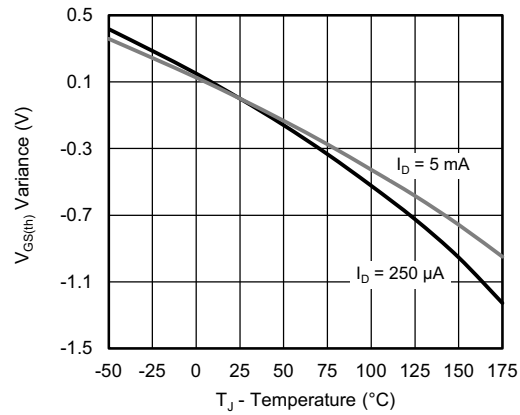
On-Resistance vs. Junction Temperature



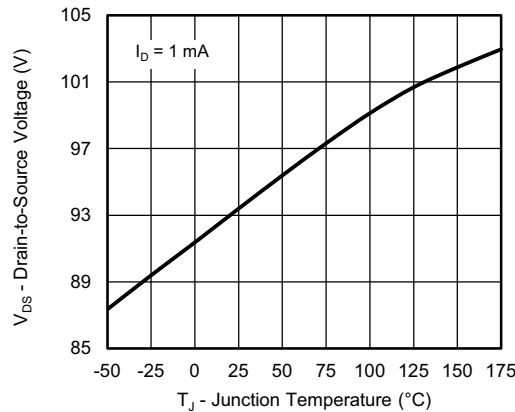
Source Drain Diode Forward Voltage



On-Resistance vs. Gate-to-Source Voltage

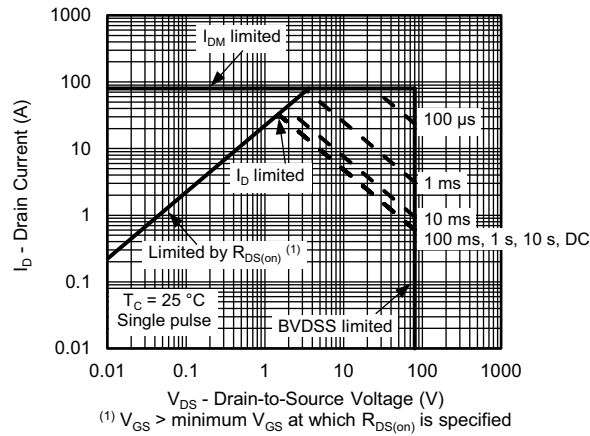

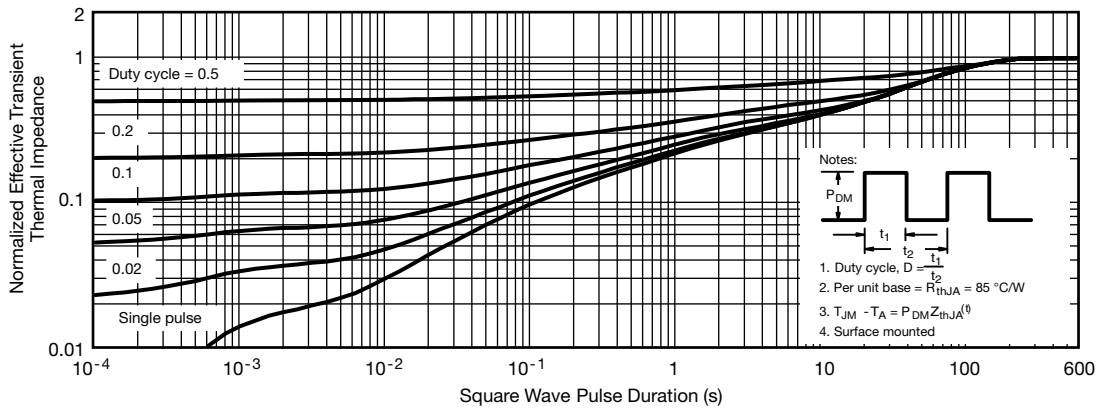


Drain Source Breakdown vs. Junction Temperature

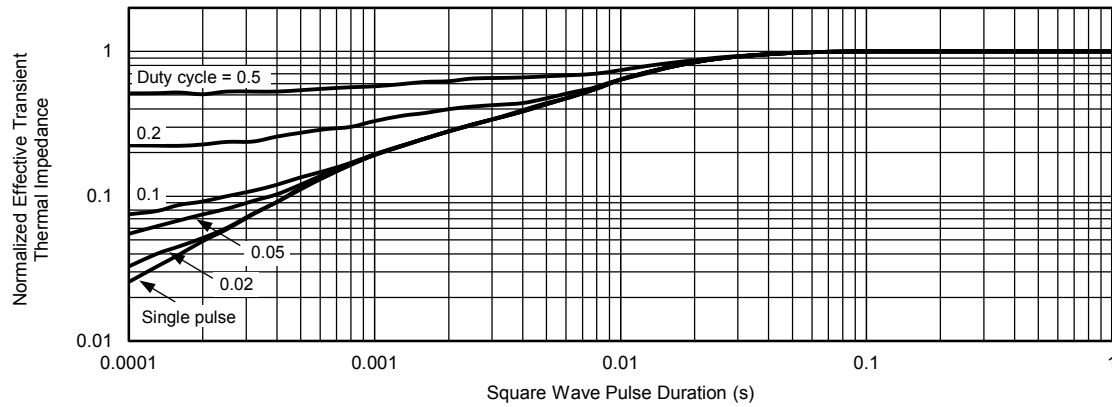
Safe Operating Area

Normalized Thermal Transient Impedance, Junction-to-Case

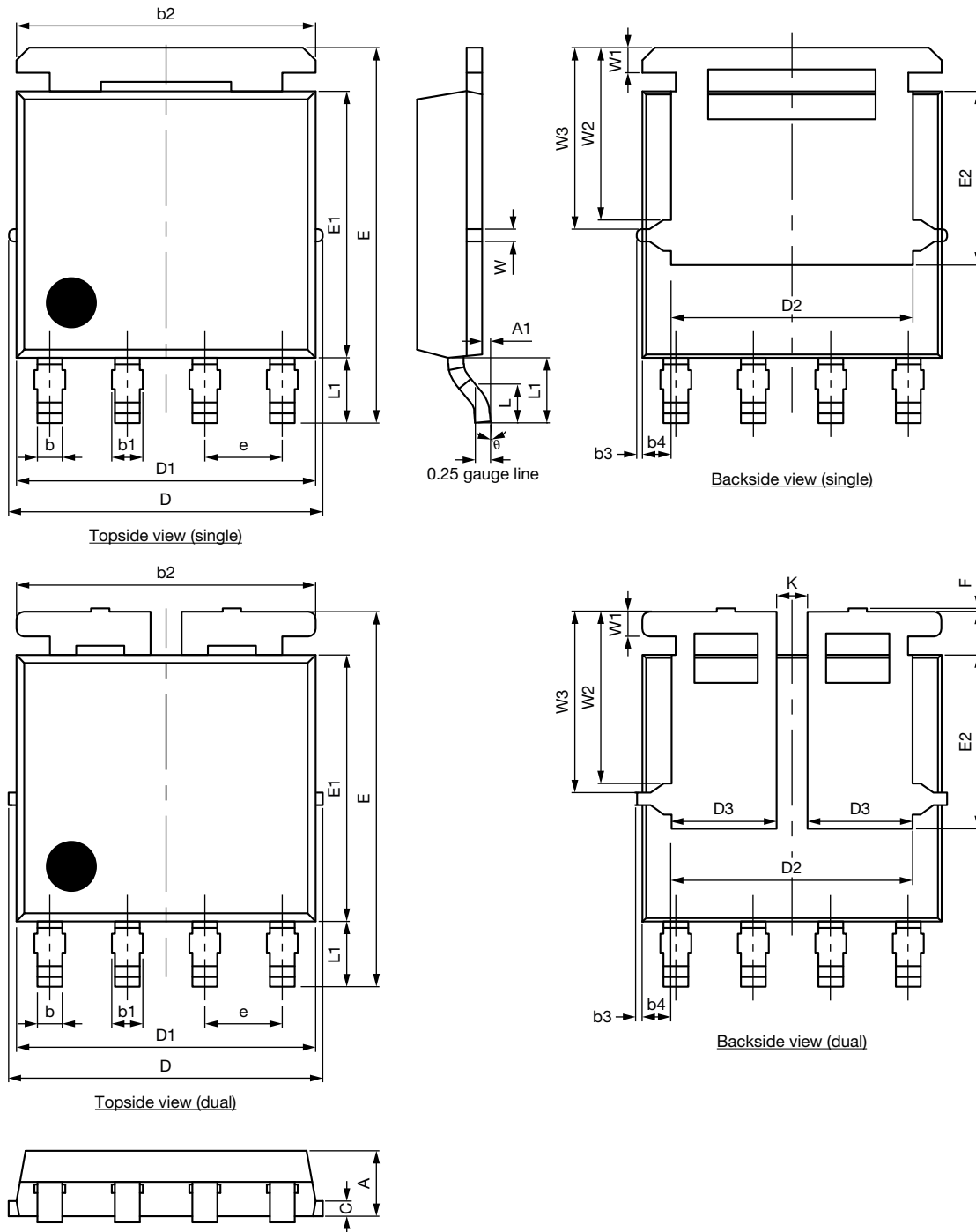

The latter is valid for the part mounted on printed circuit board - FR4, size 1" x 1" x 0.062", double sided with 2 oz. copper, 100 % on both sides. 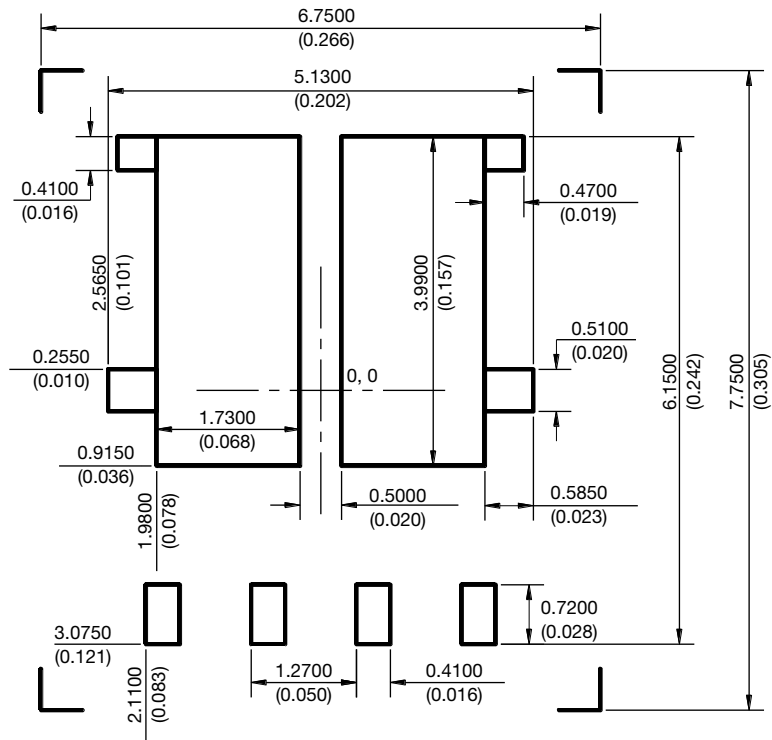
