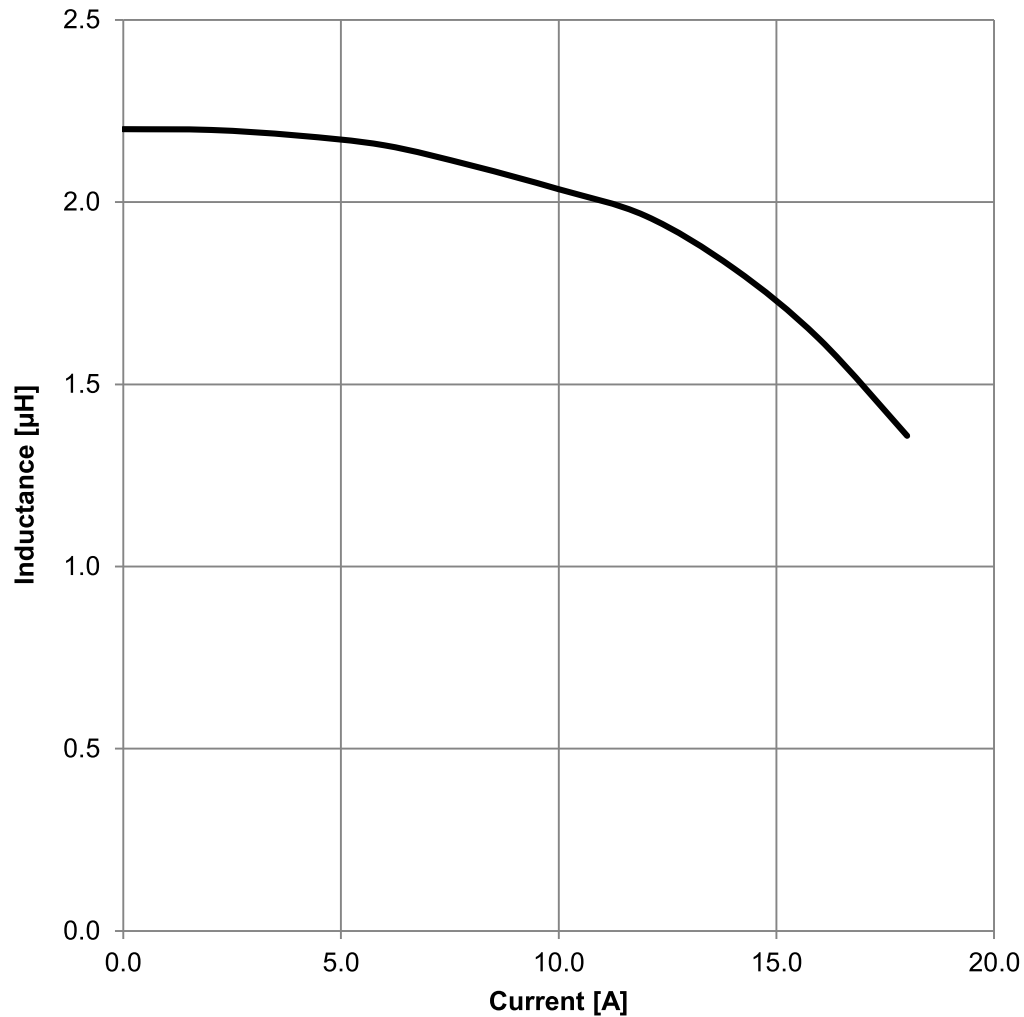

Typical Impedance Characteristics:

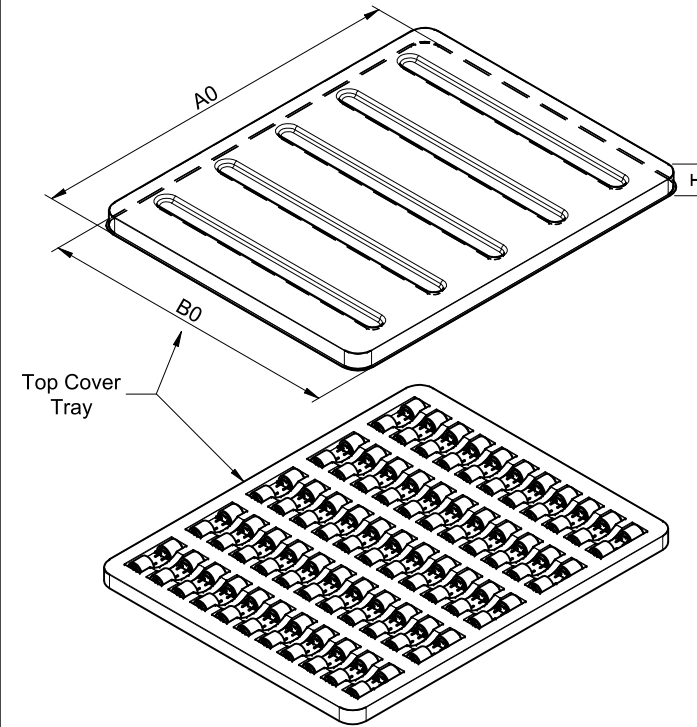
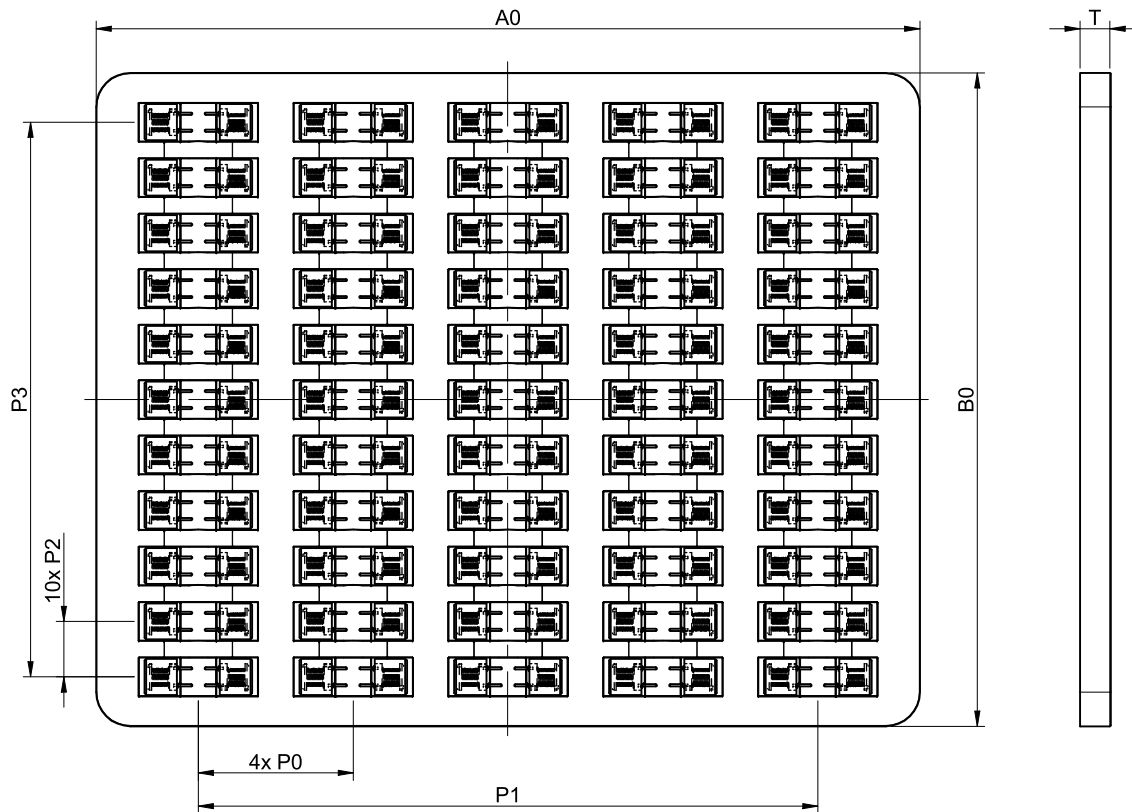


Storage Conditions:


