




Fig 1. Forward current as a function of forward voltage; typical values



Based on square wave currents.



Fig 2. Non-repetitive peak forward current as a function of pulse duration; maximum values




- (1) $T_{amb} = 150 \, ^{\circ}C$

- (4) $T_{amb} = -40 \, ^{\circ}C$


Fig 3. Reverse current as a function of reverse voltage; typical values




