














On-Resistance vs. Junction Temperature




Source Drain Diode Forward Voltage


On-Resistance vs. Gate-to Source Voltage




Drain Source Breakdown vs. Junction Temperature






PowerPAK® SO-8L Case Outline for Non-Al Parts


