




**On-Resistance vs. Gate-to-Source Voltage**





Square Wave Pulse Duration (s)

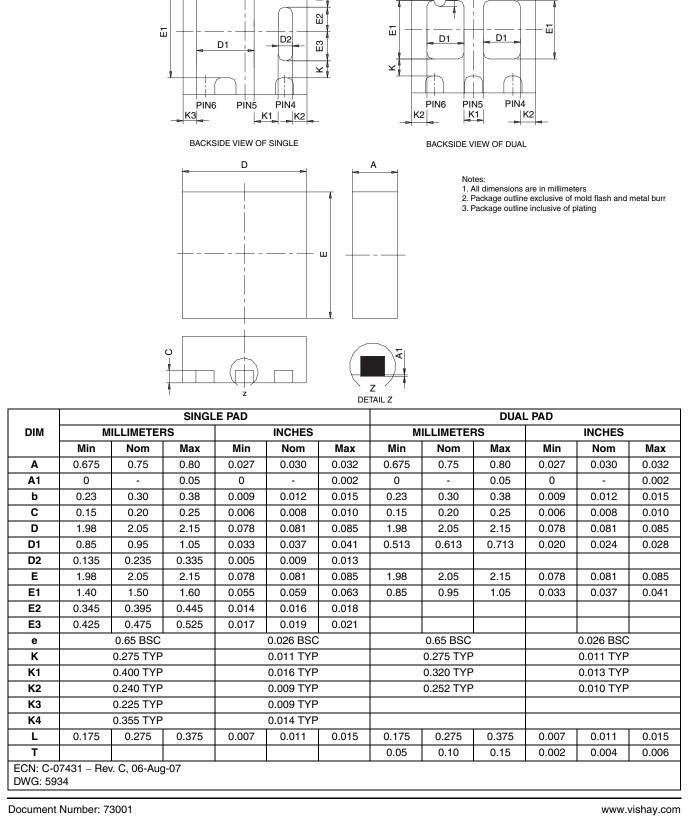


