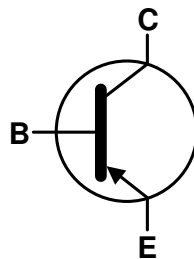

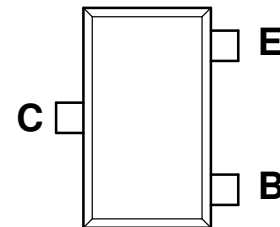

Top View



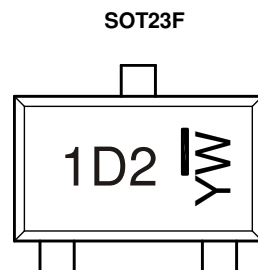
Device Symbol
