**Package Outline Dimensions**

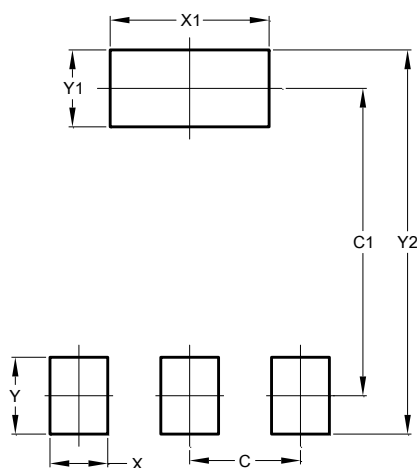
